INTERGOVERNMENTAL AGREEMENT

BETWEEN
THE STATE OF ARIZONA,
AND
THE CITY OF MESA

I. RECITALS

- 1. The State is empowered by Arizona Revised Statutes § 28-401 to enter into this Agreement and has delegated to the undersigned the authority to execute this Agreement on behalf of the State.
- 2. The City is empowered by Arizona Revised Statutes § 48-572 to enter into this Agreement and has by resolution, a copy of which is attached hereto and made a part hereof, resolved to enter into this Agreement and has authorized the undersigned to execute this Agreement on behalf of the City.
- 3. The City will design and construct a 2.5 mile, 10-foot concrete multi-use pathway from the Crosscut Canal Stadium connector beginning East of Center Street and ending past Dobson Road, ("the Project"). The Project will include improvements to the sidewalk ramps located in the State's right-of-way at the southeast corner of Dobson Road and the 202L Red Mountain Freeway. The Project will be designed and constructed to City standards. The City will design, construct, operate, and maintain this pathway in accordance with the City's policies and procedures.
- 4. The Parties shall perform their responsibilities consistent with this Agreement and any change or modification to the Project will only occur with the mutual written consent of both Parties.

THEREFORE, in consideration of the mutual covenants expressed herein, it is agreed as follows:

II. SCOPE OF WORK

1. The State will:

a. Review the design documents required for construction of the City's Project elements that are to be constructed in the State's right-of-way, and provide comments to the City.

- b. Issue, per established procedures of the State's Central District Permit Office, a valid blanket Encroachment Permit for the construction, operation, and routine or emergency maintenance work to be provided by the City within the State's rights-of-way. Process any other Encroachment Permits that may be needed to work within the State's right-of-way to effectively meet the obligations set forth for the City in this Agreement. The State agrees all activities that are reasonably required to be performed by the City under this Agreement shall be set forth in and covered by the appropriate Encroachment Permit.
- c. Be granted access to the Project area, as required, to conduct any and all maintenance related activities of the Dobson Road and the 202L Red Mountain Freeway traffic interchange.

2. The City will:

- a. Prepare and provide the design plans, specifications and other such documents and services required for the construction of the Project and incorporate comments from the State.
- b. Comply with all applicable ADA standards while improving the ramp at the southeast corner of Dobson Road /202L Red Mountain Freeway traffic interchange.
- c. Comply with all applicable ADA standards associated with the pedestrian push buttons located along the south ramp crossings of Dobson Road and the 202 Red Mountain Freeway.
- d. Restripe the intersection markings at the south leg of Dobson Road and the 202L Red Mountain Freeway in order to operate the configuration of the ADA improvements mentioned above.
- e. Request and maintain, per established procedures of the State's Central District Permit Office, a valid blanket Encroachment Permit for the construction, operation, and routine or emergency maintenance work to be provided by the City within the State's right-of-way. Agree to obtain separate permits for any new construction or installations in accordance with the Central District's established procedures. The City agrees all activities performed by the City under this Agreement shall be set forth in and covered by the appropriate Encroachment Permit.

III. MISCELLANEOUS PROVISIONS

- 1. The terms, conditions and provisions of the Agreement shall remain in full force and until the completion of the Project; however, any provisions for maintenance shall be perpetual unless assumed by another competent entity.
- 2. The City shall indemnify, defend, and hold harmless the State, any of its departments, agencies, officers or employees (collectively referred to in this paragraph as the "State") from any and all claims, demands, suits, actions, proceedings, loss, cost and damages of every kind and description, including reasonable attorneys' fees and/or litigation expenses (collectively referred to in this paragraph as the "Claims"), which may be brought or made against or incurred by the State on account of loss of or damage to any property or for injuries to or death of any person, to the extent caused by, arising out of, or contributed to, by reasons of any alleged act, omission, professional error, fault, mistake, or negligence of the City, its employees, officers, directors,

agents, representatives, or contractors, their employees, agents, or representatives in connection with or incident to the performance of this Agreement. The City's obligations under this paragraph shall not extend to any Claims to the extent caused by the negligence of the State, except the obligation does apply to any negligence of the City which may be legally imputed to the State by virtue of the State's ownership or possession of land. The City's obligations under this paragraph shall survive the termination of this Agreement.

- 3. The State shall include Section 107.13 of the 2008 version of the Arizona Department of Transportation Standard Specifications for Road and Bridge Construction, incorporated to this Agreement by reference, in the State's contract with any and all contractors, of which the City shall be specifically named as a third-party beneficiary. This provision may not be amended without the approval of the City.
- 4. This Agreement shall become effective upon signing and dating of the Determination Letter by the State's Attorney General.
- This Agreement may be cancelled in accordance with Arizona Revised Statutes § 38-511.
- 6. To the extent applicable under law, the provisions set forth in Arizona Revised Statutes §§ 35-214 and 35-215 shall apply to this Agreement.
- 7. This Agreement is subject to all applicable provisions of the Americans with Disabilities Act (Public Law 101-336, 42 U.S.C. 12101-12213) and all applicable federal regulations under the Act, including 28 CFR Parts 35 and 36. The parties to this Agreement shall comply with Executive Order Number 2009-09 issued by the Governor of the State of Arizona and incorporated herein by reference regarding "Non-Discrimination".
- 8. In the event of any controversy, which may arise out of this Agreement, the Parties hereto agree to abide by required arbitration as is set forth for public works contracts in Arizona Revised Statutes § 12-1518.
- 9. The Parties shall comply with the applicable requirements of Arizona Revised Statutes § 41-4401.
- 10. The Parties hereto shall comply with all applicable laws, rules, regulations and ordinances, as may be amended.
- 11. All notices or demands upon any Party to this Agreement shall be in writing and shall be delivered in person or sent by mail, addressed as follows:
