Subject:	Three-Year Term Contract for Pawn Web-Based Application for the Police Department (Citywide)

Purpose and Recommendation

Council is requested to approve the Term Contract for Pawn Web-Based Application as recommended. A committee representing the Police Department and Purchasing evaluated responses.

The evaluation committee recommends awarding the contract to the highest scored proposal from LeadsOnline, LLC at \$78,672.00 annually, based on estimated requirements.

Background / Discussion

This contract will upgrade the City's current pawn application to a web-based application. The current application developed by LeadsOnline is used to monitor and maintain servicing of paper pawn tickets which is set to expire April, 2017. The Police Department plans to move from a paper pawn ticket to an electronic pawn ticket to increase staff productivity and improve business relationships with the pawnshops and second hand businesses.

The current application monitors and maintains pawn shop and second-hand store information but does not allow for purchasing and management of pawn tickets which must be purchased physically. The planned upgrades will allow the Department to offer tickets 24/7 from a website, eliminate voided tickets, print out current and historical transactions and statements, automatically gather various statistics and benchmarks, and electronically report transactions to Maricopa County Sheriff's Office (MCSO); Reporting this information to MSCO is mandated under A.R.S. Title 44-1625.

Thirteen staff from the Police Department (from Technical Security, Desktop Infrastructure, PD Pawn and Fiscal) evaluated the proposals based on the evaluation criteria as stated in the solicitation. The highest scored proposal, LeadsOnline, LLC is being recommended for award. LeadsOnLine provides the current application used by the Police Department that interfaces with MCSO. Vendor will develop and add e-ticket option. The evaluation committee unanimously agreed on the recommendation.

Alternatives

Council may choose not to authorize the purchase and new responses will be solicited.

Fiscal Impact

The annual contract amount is available in the Police Department – Technical Services operating budget.
