Subject:	One-Year Renewal Contract for Traffic Sign Posts for the Materials and Supply Warehouse (for the Transportation Department) (Citywide)

Purpose and Recommendation

Council is requested to approve the One-Year Renewal Contract for Traffic Sign Posts as recommended.

The Business Services, and Transportation Departments, and Purchasing recommend authorizing the renewal with Xcessories Squared Southwest, Inc. at \$80,000.00, based on estimated requirements.

Background / Discussion

This contract provides galvanized metal sign post materials that are stocked at the Materials and Supply Warehouse for use by the Transportation Department. The materials are for the installation, replacement and/or relocation of traffic control and street name signs throughout the City.

Council approved the initial three-year contract with renewal options on February 25, 2013, and the first, one-year renewal on December 1, 2015. This is the second and final, one-year renewal contract.

The vendor offered to renew the contract with a 2% price decrease in line with the market. The City and vendor negotiated and agreed to the 2% reduction for the one-year renewal from 3/1/2017 through 2/28/2018. The City has been satisfied with the vendor's performance. This contract continues to be advantageous to the City and it is in the City's best interest to renew the contract.

Alternatives

Council may choose not to authorize the purchase and new responses will be solicited.

Fiscal Impact

The annual contract amount is available through the Warehouse Internal Service Fund.
