A RESOLUTION OF THE COUNCIL OF THE CITY OF MESA, MARICOPA COUNTY, ARIZONA, APPROVING A SCHEDULE OF FEES AND CHARGES RELATED TO PAVEMENT CUTS.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESA, COUNTY OF MARICOPA, STATE OF ARIZONA, AS FOLLOWS:

WHEREAS, proposed amendments to Title 9, Chapter 1 of the City Code establishes a requirement to pay pavement restoration fees for cutting pavement that is newer than five years old. A four-tier rate structure is based on pavement age and size of cut.

WHEREAS, the City Council considered the amendments to Title 9, Chapter 1 on December 12, 2016 and January 9, 2016.

WHEREAS, in connection with the enactment of the ordinance amendments, the fee schedule attached hereto as Exhibit A will establish various City officers and employees are hereby authorized and directed to perform all acts necessary to give effect to this Resolution.
