Subject: Three-Year Term Contract for Fiberglass Waterslide Repair for the Parks, Recreation and Community Facilities Department **(Citywide)**

Purpose and Recommendation

Council is requested to approve the Three-Year Term Contract for Fiberglass Waterslide Repair as recommended.

The Parks, Recreation and Community Facilities Department, and Purchasing recommend awarding the contract to the lowest, responsive and responsible bidder, 8 Blocks Maintenance Co., LLC at \$56,884.50 annually, based on estimated requirements.

Background / Discussion

This contract will provide for the repair, waxing and buffing of the City's nine full-size fiberglass waterslides, two fiberglass kiddie slides and one cementitious/vinyl kiddie slide at various locations. Each year, preventative maintenance and repairs on every waterslide at each Aquatics facility is necessary. It is the only way to ascertain the fiberglass is safe and will not cause injury to a potential rider for the upcoming year. Any splinters, grooves, and/or fiberglass shards that may cut riders are sanded off and polished to help maintain the overall safety and appearance of the slide. It is during this service that potential leaks are found and can be repaired before major damage occurs.

Alternatives

Council may choose not to award the contract and new responses will be solicited.

Fiscal Impact

The annual contract amount is funded by the Parks, Recreation and Community Facilities Department operating budget.
