Subject: Three-Year Term Contract to Repair and Refurbish Metal Bins and Roll-Off Containers for the Environmental Management and Sustainability Department
(Citywide)

Purpose and Recommendation

Council is requested to approve the Term Contract to Repair and Refurbish Metal Bins and Roll-Off Containers as recommended. A committee representing the Environmental Management and Sustainability Department and Purchasing evaluated responses.

The evaluation committee recommends awarding the contract to the two respondents, Wastebuilt LLC and Colby Welding & Radiator Inc., cumulatively not to exceed \$150,000.00 annually, based on estimated requirements.

Background / Discussion

This contract will provide repair and refurbishment of the metal bins and roll-off containers used to service commercial and residential solid waste customers. These bins and containers become damaged over time due to normal usage, wear and tear.

Staff from the Environmental Management and Sustainability Department evaluated the two proposals through comparative analysis. Wastebuilt LLC and Colby Welding & Radiator Inc. were both deemed as qualified and are being recommended for award. The evaluation team recommends to award to multiple providers in order to ensure continuity of services and obtain an overall low price. The Team believes a multiple award provides the best benefit to the City and its Citizens. The evaluation committee unanimously agreed on the recommendation.

Alternatives

Council may choose not to authorize the purchase and new responses will be solicited.

The annual contract amount is available in the Environmental Management and Sustainability Department operating budget.
