Subject:	Three-Year Term Contract for Interpreter/Translation Services for the Police, Municipal Court, City Clerk and Community Services Departments (Citywide)

#### **Purpose and Recommendation**

Council is requested to approve the Term Contract for Interpretation/Translation Services as recommended. A committee representing Police, Municipal Court, City Clerk, Community Services Departments and Purchasing evaluated responses.

The evaluation committee recommends awarding the contract to the highest scored proposals from: AZ Language Solutions LLC; CyraCom International, Inc. dba Voiance Language Services, LLC; Finger Works, Inc.; Language Connection, Language Line Services, Inc.; Spanish Media & Translation Services, LLC (a Mesa business); and Topete/Stonefield, Inc.; cumulatively not to exceed \$100,000.00 annually, based on estimated requirements.

#### **Background / Discussion**

This contract will provide multiple qualified foreign language (certified interpreters and/or translators) to provide Interpretation/Translation Services to the City on an as-needed basis to include in-person, over the phone, as well as document interpretation, American Sign Language (ASL), and/or translation services.

The City is committed to recognizing and respecting its diverse community through inclusive programs and services. Providing information in alternative languages is part of that effort and to meeting our federal requirements identified in the Citywide Title VI Implementation Plan and Limited English Proficiency (LEP) Plan. As such, the Police, Municipal Court, City Clerk and Community Services Departments require the services of a qualified foreign language interpreter and/or translator to provide services for non-English speaking community members involved in City business matters.

The solicitation stated the City's intent to award multiple contracts to ensure adequate services are available to the community members and provide adequate coverage for all required areas, including a backup vendor for 9-1-1 Dispatch.

The City received 22 proposals of which all 22 met the minimum requirements. Staff from Police, Municipal Court, City Clerk and Community Services Departments evaluated the 22 proposals and completed the Preliminary Scoring based on the solicitation's evaluation criteria; Proposals including: Acceant, LLC; Alejandra S. Torres; Certifieds Only

Principals; French Interpretation and Translation Services; Arizona Freelance Interpreting Svcs.; Language Concepts; Professional Court Interpreting & Translating Services; Minh Tuyet Pham; Susana P. Menendez; Telelanguage, Inc.; The Language Link of Connecticut; and World Wide Interpreters Inc.; were deemed not reasonably susceptible for award and were not considered further (a notification was sent to each vendor).

The evaluation team completed the Final Scoring of the remaining nine responses based on the evaluation criteria as stated in the solicitation. The evaluation team recommended the seven highest scored proposers for award: AZ Language Solutions LLC, Voiance Language Services, LLC, Finger Works, Inc., Language Connection; Language Line Services, Inc.; Spanish Media & Translation Services, LLC.; and Topete/Stonefield, Inc. The evaluation committee unanimously agreed on the recommendation.

## Alternatives

Council may choose not to authorize the purchase and new responses will be solicited.

#### **Fiscal Impact**

The annual contract amount is cumulatively available through the Department's operating budget utilizing Interpretation/Translation Services.
