**Subject:** Purchase of One Replacement, Light-Duty Truck with a Utility Bed for the Parks Recreation and Community Facilities Department **(Funded by the Vehicle Replacement Fund) (Citywide)**

## Purpose and Recommendation

Council is requested to approve the purchase of one replacement, light-duty, 4X2 truck with an 8 ft. utility bed as recommended.

The Fleet Services and Parks Recreation and Community Facilities Departments, and Purchasing recommend authorizing the purchase from the contract with Berge Ford (a Mesa business) at \$38,813.29.

## Background / Discussion

This vehicle is being replaced as part of the ongoing City of Mesa vehicle replacement program managed by Fleet Services. The vehicle being replaced has met established criteria and will be either traded, auctioned, sold, or deployed to special uses.

This vehicle is an additional purchase from a contract Council awarded on July 1, 2015 that allows additional purchases.

## Alternatives

Council may choose not to authorize the purchase and new responses will be solicited.

## Fiscal Impact

This purchase is funded by the Vehicle Replacement Fund.
