Subject: Purchase of Two Replacement Meter Test Boards for the Energy Resources

Department (Single Response) (Funded by the Utility Replacement

Extension and Renewal Fund) (Citywide)

Purpose and Recommendation

Council is requested to approve the Purchase of Two Replacement Meter Test Boards as recommended.

The Energy Resources Department – Electric Utility and Purchasing recommend awarding the contract to the single, responsive and responsible bidder, Watthour Engineering Co., Inc., at \$81,653.63.

Background / Discussion

This purchase will provide one, 3-phase bench mounted unit and one, single-phase portable unit, used to test the accuracy of all meters in the Electric distribution system to measure customer consumption and to bill customers for energy usage. The new meter test boards will replace two existing less efficient, less reliable single-phase meter test boards that are over ten years old and in disrepair.

The number of breakdowns and malfunctions of the existing meter testing equipment has been increasing and adversely affects productivity. The manufacturer has discontinued support for repairs and the service company used to annually certify proper calibration of the meter test boards will no longer support certification and calibration. In addition, the original system operating software for the existing meter test boards is incompatible with the City's Windows 7 operating system and has required acquisition of an alternative software. The old units are obsolete and will be scrapped.

Thirty vendors downloaded the solicitation including all vendors identified by the Energy Resources Department. Purchasing determined the pricing submitted is fair and reasonable and all vendors had reasonable opportunity to respond and there is not adequate time to re-solicit.

Alternatives

Council may choose not to authorize the purchase and new responses will be solicited.

Fiscal Impact

This purchase is funded by the Utility Replacement Extension and Renewal Fund.
