Subject:	Three-Year Term Contract for Backflow Testing and Repair Services for various City Departments (Citywide)		

Purpose and Recommendation

Council is requested to approve the Term Contract for Backflow Testing and Repair Services as recommended. A committee representing the Transportation, Water Resources, Parks, Recreation and Community Facilities Departments, and Purchasing evaluated responses.

The evaluation committee recommends awarding the contract to the highest scored proposal, Metro Fire Equipment, Inc., at \$90,000.00 annually, based on estimated requirements.

Background / Discussion

This contract will provide backflow assembly testing and repair services for various City Departments including Transportation, Water Resources, Parks, Recreation and Community Facilities. The contracted vendor will provide testing, repair, and report transmittals in a timely manner ensuring the backflow assemblies are in good working condition and in compliance with municipal code. The contract will be administered by the Water Resources Department Cross Connection Control Office.

The City received 4 proposals of which all 4 met the minimum requirements. Staff from Transportation, Water Resources, Parks, Recreation and Community Facilities Departments, and Purchasing evaluated the proposals and completed scoring based on the evaluation criteria as stated in the solicitation. The highest scored proposal, Metro Fire Equipment, Inc., is being recommended for award. The evaluation committee unanimously agreed on the recommendation.

Alternatives

Council may choose not to authorize the purchase and new responses will be solicited.

Fiscal Impact

The annual contract amount is cumulatively available in the Transportation, Water Resources, Parks, Recreation and Community Facilities Department's operating budgets.
