**Subject:** Three-Year Term Contract for Uninterruptible Power Supplies Purchase,

Maintenance and Repair Services for the Water Resources and Parks,

Recreation and Community Facilities Departments (Citywide)

#### **Purpose and Recommendation**

Council is requested to approve the Term Contract for Uninterruptible Power Supplies Purchase, Maintenance and Repair Services as recommended. A committee representing Water Resources and Purchasing evaluated responses.

The evaluation committee recommends awarding the contract to the highest scored proposal from Titan Power, Inc., at \$100,000.00 annually, based on estimated requirements.

## **Background / Discussion**

This contract will provide for the maintenance and repair of existing Uninterruptable Power Supplies (UPS) equipment, and the purchase and maintenance of any new UPS equipment for Water Resources facilities such as the Utilities Building, Southeast WRP, Brown Road WTP Signal Butte WTP and Greenfield WRP; and City facilities maintained by PRCF, Facilities Maintenance for lifecycle battery replacements at Police Main, Forensics and Amphitheater and UPS maintenance as needed.

The vendor supplies all labor, materials, transportation and equipment for UPS installation, integration and implementation. All products and work performed is in compliance with the City's specifications for UPS products and services, and UPS preventative maintenance schedules and tasks.

Purchasing conducted the initial review of the six proposals received to determine if minimum qualifications were met. Five of the six proposals met minimum qualifications which were brought forward to the evaluation team for review. Staff from the Water Resources Department evaluated the proposals based on the evaluation criteria as stated in the solicitation. The highest scored proposal, Titan Power Inc., is being recommended for award. The evaluation committee unanimously agreed on the recommendation.

#### **Alternatives**

Council may choose not to authorize the purchase and new responses will be solicited.

### **Fiscal Impact**

The annual contract amount is available in the Water Resources Department operating budget through Water and Wastewater O & M (\$50,000) and the PRCF – Facilities Maintenance operating budget (\$50,000).
