Subject:	Three-Year Term Contract for Utility Adjustment Services for the Transportation Department (Citywide)

Purpose and Recommendation

Council is requested to approve the Term Contract for Utility Adjustment Services as recommended.

The Transportation Department and Purchasing recommend awarding the contract to the lowest, responsive and responsible bidder, Lincoln Constructors Inc., at \$515,120.00 annually, based on estimated requirements.

Background / Discussion

Work under this contract will include minor concrete work and the adjustment of gas and water valves, survey monuments, sewer cleanouts, and manholes associated with utility cut repairs and/or failed utility frames and other related services. Utility repairs to manholes and valves are essential for roadway safety; reducing hazards such as failing and/or sinking manholes and valves.

Alternatives

Council may choose not to authorize the purchase and new responses will be solicited.
