Deletions are shown as strike-outs: Abe. Additions to the text are shown in bold and capital letters: ABC. Fee amounts carried forward are shown as "no change". Existing fees and charges that are being relocated in the Schedule are marked with an \*. New or increased fee amounts are shown in bold: \$10.00.

<u>Section 2:</u> All fees and charges for services provided by the Parks, Recreation, and Community Facilities Department previously approved and adopted and not amended or increased by this Resolution remain in effect.

<u>Section 3</u>: The various City officers and employees are hereby authorized and directed to perform all acts necessary to give effect to this Resolution.
