Community Services Departments (Funded by the Vehicle Replacement Fund) and One Replacement Sedan for the Environmental Management and Sustainability Department (Funded by the Environmental Compliance Fee)

(Single Response) (Citywide)

## **Purpose and Recommendation**

Council is requested to approve the Purchase of Two Minivans and One Sedan as recommended.

The Fleet Services, Police, Community Services, and Environmental Management and Sustainability Departments, and Purchasing recommend authorizing the purchase from the single, responsive and responsible bidder, Larry H. Miller Toyota at \$94,680.75.

#### **Background / Discussion**

The three vehicles that are being replaced have met established criteria and will be either traded, auctioned, sold, or deployed to special uses as part of the ongoing City of Mesa vehicle replacement program.

This was the second Request for Bids for these vehicles, the first time only one response was received but was deemed non-responsive. Prior to re-issuing the solicitation, Purchasing reached out to four East valley Toyota dealerships. These vendors all expressed a desire to submit a response, however, none of them submitted a response. One dealership mentioned the paperwork and requirements were not worth the profit if awarded the contract. Purchasing feels the single response's pricing is fair and reasonable and re-issuing a third solicitation would not generate any additional responses.

#### **Alternatives**

Council may choose not to authorize the purchase and new responses will be solicited.

This purchase is funded by the Vehicle Replacement and Environmental Compliance Fee.
