AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MESA, ARIZONA AMENDING SECTION 9-6-3 OF THE MESA CITY CODE REMOVING AN OUTDATED SIGHT VISIBILITY FIGURE FROM THE SUBDIVISION REGULATIONS; AMENDING SECTIONS 9-6-4 AND 9-8-3 REGARDING THE INSTALLATION OF STREET NAME SIGNS WITHIN THE SUBDIVISION AND OFF-SITE IMPROVEMENT REGULATIONS; AND PROVIDING PENALTIES FOR THE VIOLATION THEREOF.

THEREFORE BE IT ORDAINED by the City Council of the City of Mesa, Maricopa County, as follows:

Text written in **BOLD ALL CAPS** indicates new language. Strikethrough fonts indicate deletions.

Section 1: That Section 9-6-3(C)4.(i) of the Mesa City Code is hereby amended as follows:

All street intersections shall be designed to meet minimum sight distance visibility requirements (see Figure 20 REFER TO ENGINEERING PROCEDURE MANUAL FOR SPECIFIC REQUIREMENTS).

In addition, Figure 20 shall be removed from said Section.

Section 2: That Section 9-6-4(D)12. of the Mesa City Code is hereby amended as follows:

Street Name Signs. Street name signs shall be placed in all street intersections. The subdivider shall install signposts **AND SIGNS** meeting City standards at locations designated **PER MESA STANDARD DETAILS WITH DESIGNS APPOVED** by the City **TRAFFIC** Engineer. The signposts shall be in place prior to the completion of street paving. Prior to the issuance of a City permit for street paving, the subdivider shall pay to the City an amount per street name sign location as determined by the City Engineer to pay for the fabrication and installation of sign plates by the City.

<u>Section 3:</u> That Section 9-8-3(H)10. of the Mesa City Code is hereby amended as follows:

Street Name Signs. Street name signs shall be placed in all street intersections. The developer shall install signposts **AND SIGNS** meeting City standards at locations designated **PER MESA STANDARD DETAILS WITH DESIGNS APPOVED** by the City **TRAFFIC** Engineer. The signposts shall be in place prior to the completion of street paving. Prior to the issuance of a City permit for street paving, the developer shall pay to the City an amount, as determined by the City Engineer, per street name sign location for the fabrication and installation of sign units by the City.

Section 4: PENALTIES:

- (A) It is unlawful to develop land contrary to or in violation of any provisions of this Chapter or of any provisions designated as a condition of approval either by the plan review process or through an amendment, variance, or appeal by an office, board, commission, or the City Council as established by this Chapter.
- (B) Any person, firm, or corporation violating any provision of this Chapter and any amendment to it shall be guilty of a Class 1 misdemeanor, punishable by a fine not to exceed two thousand five hundred dollars (\$2,500.00) or by imprisonment in the City jail for a period not to exceed six (6) months, or by both such fine and imprisonment; and each day of violation continued shall be a separate offense, punishable as described.
