Subject:	One-Year Renewal Contract for Juniper Network Technical Support Services for the Information Technology Department – Communications and Infrastructure (Citywide)

#### Purpose and Recommendation

Council is requested to approve the Renewal Contract for Juniper Network Technical Support Services as recommended.

The Information Technology Department - Communications and Infrastructure and Purchasing recommend authorizing the renewal with Enterprise Networks Solutions (a Mesa business) at \$41,560.35 annually, based on estimated requirements.

#### **Background / Discussion**

This contract provides technical support services, including an extended warranty, to assist City staff in the maintenance and engineering of the microwave core network consisting of Juniper routers and switches. This equipment is used to transport City network data including fire station alerting, telephone, utilities, and other digital communications over the City's private microwave radio network. The purpose of this contract is to provide an extended warranty including a no charge ten-day equipment replacement, all software and firmware upgrades, and factory technical support for the Juniper Network equipment.

Enterprise Networks Solutions offered to renew the contract with a 7.6% increase. Purchasing negotiated and the vendor agreed on 2% based on the Consumer Price Index. The second lowest bidder when originally bid in 2014 was 27% higher. This vendor has held this contract for the past three years and the City has been satisfied with the vendor's performance. This contract continues to be advantageous to the City and it is in the City's best interest to renew the contract.

## Alternatives

Council may choose not to authorize the purchase and new responses will be solicited.

## **Fiscal Impact**

The annual contract amount is available in the Information Technology Department – Communications and Infrastructure operating budget.
