### RESOLUTION NO.

### A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESA, MARICOPA COUNTY, ARIZONA, TO ABANDON PORTIONS OF THE RIGHT-OF-WAY IN THE 2100 BLOCK OF WEST RIO SALADO PARKWAY AND A PORTION OF RIGHT OF WAY NEAR THE INTERSECTION OF WEST RIVERVIEW AUTO DRIVE AND CUBS WAY.

WHEREAS, the City Council has determined that portions of the public Right-of-Way in the 2100 West Rio Salado Parkway and a portion of Right-of-Way near the intersection of West Riverview Auto Drive and Cubs Way, as hereafter described, are no longer needed.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESA, MARICOPA COUNTY, ARIZONA, AS FOLLOWS:

Section 1: Pursuant to the provisions of Section 28-7205, Arizona Revised Statutes, the rights of the City of Mesa in and to the public Rights-of-Way as described on the attached Exhibit A are abandoned.

### PLEASE REFER TO EXHIBIT "A" ATTACHED HERETO AND BY THIS REFERENCE MADE A PART HEREOF.

Title to the vacated Rights-of-Way shall vest in the owner of the abutting land pursuant to ARS Section 28-7205; subject to the same encumbrances, liens, limitations, restrictions and estates as exist on the land to which it accrues.
