Subject:	Eight-Month Term Contract for Short Line Pavement Marking Services for the Transportation Department (Citywide)

## **Purpose and Recommendation**

Council is requested to approve the Term Contract for Short Line Pavement Marking Services as recommended.

The Transportation Department and Purchasing recommend authorizing the contract with the lowest, responsive and responsible bidder, Falcon Contracting at \$78,700.00 through June 30, 2018, based on estimated requirements.

#### **Background / Discussion**

This contract will provide short line pavement marking services for Transportation, Traffic Operations. Short line marking services include the installation of traffic marking symbols and legends installed with thermoplastic, preformed tape, or waterborne paint. Additional work will include design layout to meet current design specifications and the removal of mainline and short line traffic markings, symbols and legends.

This contract is a re-solicitation of Contract No. 2015219 for Short Line Pavement Marking Services only (Group B). Council awarded these services to RoadSafe Traffic Systems on June 1, 2015. This vendor no longer provides short line services. This contract (No. 2018023) for Short Line Services will be valid through 6/30/2018. The City currently intends to re-bid the contract for both Mainline and Short Line Pavement Marking Services prior to June 30, 2018.

## Alternatives

Council may choose not to authorize the purchase and new responses will be solicited.

The annual contract amount is available in the Transportation Department operating budget.
