Subject: Three-Year Term Contract for Ultraviolet Lamp Assemblies for the Water Resources Department **(Citywide)**

Purpose and Recommendation

Council is requested to approve the Term Contract for Ultraviolet Lamp Assemblies as recommended.

The Water Resources Department and Purchasing recommend awarding the contract to the lowest, responsive and responsible bidder, UV Superstore, Inc., at \$29,700.00 annually, based on estimated requirements.

Background / Discussion

The Northwest Water Reclamation Plant utilizes an Ultra Violet disinfection system (Trojan Technologies UV3000 Plus) to aid in wastewater disinfection. The City has purchased quality aftermarket lamps for this system for the past several years. The products specified in this bid are for items that are already tested and found to be acceptable by the City.

This contract will provide First Light USA, Inc., #FL-3228 lamp assemblies. The City has successfully used #FL-3228 for more than three years with no issues. Other aftermarket lamps were tried and due to inconsistent quality issues, the City only considered #FL-3228 lamps for this bid.

Alternatives

Council may choose not to authorize the purchase and new responses will be solicited.

Fiscal Impact

The annual contract amount is funded by the Water Resources Department – Wastewater Operations and Maintenance operating budget.
