1. Motion to convene Public Hearing

A motion to convene Public Hearing #1 was made by Susan Brenton; seconded by Stephen Sparks; the motion was carried by a vote of 8-0.

2. Discussion regarding the proposed funding of the following:

The First Substantial Amendment to the FY 2017/2018 Annual Action Plan was taken to City Council on Thursday, October 5th, and the proposed funding was accepted unanimously. A 30-Day Public Comment Period commenced on Thursday, October 5th, and will end on Friday, November 3rd. A second hearing will be held on Monday, October 16th.
