Subject: One-Year Renewal Contract for Water and Wastewater Vertical Turbine Pump Repair/Replacement for the Water Resources Department **(Citywide)**

Purpose and Recommendation

Council is requested to approve the renewal contract for Water and Wastewater Vertical Turbine Pump Repair and Replacement as recommended. A committee representing Water Resources and Purchasing evaluated responses.

The Water Resources Department and Purchasing recommend authorizing the renewal contract with Phoenix Pumps Inc. (Primary); and Weber Water Resources, LLC (Secondary); cumulatively not to exceed \$300,000.00 annually, based on estimated requirements.

Background / Discussion

There are approximately 120 vertical turbine pumps in use at the City's four plants and twelve pump stations. Repair of vertical turbine pumps is a coordinated effort between Plant Managers, Process Controls, and the vendor. This contract will provide two qualified vendors (a Primary and Secondary Contractor) to perform maintenance, repairs and replacements on vertical turbine pumps, and other water and sewer type pumps, located at City-owned water treatment plants, wastewater reclamation plants, and water supply pump stations throughout the City. This work is critical to water and wastewater operations.

Phoenix Pumps Inc. and Weber Water Resources, LLC offered to renew the contract without a pricing increase and holding pricing for four years. The Producer Price Index has increased by less than 1.2% over the last year. Both vendors have performed satisfactorily during the initial three-year term. This contract continues to be advantageous and it is in the City's best interest to renew the contract.

Alternatives

Council may choose not to authorize the purchase and new responses will be solicited.

Fiscal Impact

The annual contract amount is funded by the Water Resources - Water Utility and Wastewater Utility operating budgets.
