Subject: Small Wireless Facilities Application Fees and Annual Right of Way

Use Rates (A.R.S. 9-591 – 599 relating to small wireless facilities)

Purpose and Recommendation

The purpose of this report is to request Council approval of fees for SWF rights-of-way use fees to occupy the City's rights-of-way.

Engineering requests Council approval to change the Engineering Schedule of Fees and Charges, as outlined in this report and detailed in the attached Exhibit "A". The Fees and Charges, once approved, will be effective February 9, 2018.

Background

In March 2017, the Arizona State Legislature approved and the governor signed into law House Bill 2365, which amended Title 9, Section 5 of the Arizona Revised Statutes relating to wireless services. As a result of this bill, state law now allows wireless providers to install, operate, and maintain SWF and related equipment in city, town, and county rights-of-way and public easements as a matter of right. Mesa Electric, Salt River Project, Arizona Public Service, and the City of Yuma are exempt from the new legislation.

The state law limits the fees cities can charge for the use of the rights-of-way, plan review, and inspections services related to SWF. Cities are required to establish and make available rates, fees, and terms for deployment of SWF sites consistent with HB 2365 no later than February 9, 2018.

Discussion

In May of 2015, the City Council approved Resolution No. 10627, establishing a fee to use the rights-of-way for SWF. The fee to use the rights-of-way varied from \$3,469 to \$21,073 annually, based on the volume (cubic feet) of equipment placed in the right-of-way. The new annual fee for SWF is limited to a total of \$100 per site per year to collocate on City-owned poles and \$50 per site per year to collocate on non-City owned poles. The annual fee for new monopoles is equal to the direct and actual cost of managing the right-of-way per site per year. In addition, the amount the City may

charge for application, plan review, and inspection services range from \$50 for batched applications to \$750 per pole per site and limited to \$1000 per new monopole.

Alternatives

An alternative to updating the fees is to take no action. This is not recommended because the existing fees would remain effective until February, at which time the City would be in violation of state law.

Fiscal Impact

The proposed application and rights-of-way use fees for SWF are intended to recoup direct and actual costs associated with the processing, permitting and inspection of SWF. While the total costs associated with the processing and permitting are greater than the proposed fees, the new legislation sets a limitation on the amount the City may charge for the installation of SWF in the rights-of-way.

There is an anticipated annual revenue of \$33,010 for these fees.

Coordinated With

The recommended fees and charges were coordinated with the Office of the City Attorney and the Office of Management and Budget.
