**Subject:** Five-Year Term Contract for Electrical, Lighting, Data Communications, and

Security Products and Related Products, Services and Solutions for Citywide

Departments (Citywide)

#### Recommendation

Council is requested to approve the award as recommended.

Purchasing recommends authorizing the purchase using the U.S. Communities, City of Kansas City cooperative contract with Graybar at \$400,000.00 annually, based on estimated usage.

## **Background**

The City of Kansas City, MO as the lead agency, awarded a U.S. Communities cooperative contract to Graybar. The City has used the U.S. Communities contract with Graybar for many years and is highly satisfied with their product offering and available services. Because the current U.S. Communities contract expires on March 31, 2018, Council approval is being requested to utilize this newly awarded U.S. Communities contract with Graybar.

This is a citywide contract that multiple Departments will use and rely on to perform their jobs. Main users include Parks, Recreation and Community Facilities, the Materials and Supply Warehouse, Transportation, Communications, Information Technology, and Fire and Medical. Graybar is a key source for tools, test equipment, safety, and Maintenance, Repair and Operations (MRO) products in support of electrical, lighting, data/communications, networking and security.

Graybar works with over 300 manufacturers and offers a discount off list price ranging from 10% to 90% (general catalog equipment and supplies, tools, lighting, wire and cable, electrical, communications, and safety items) plus free freight. Users may order online for desktop delivery or go to their Mesa location for pick-up of orders.

The U.S. Communities cooperative contract was competitively bid, meets procurement requirements and prices are competitive due to nationally based volume contract pricing. It is unlikely that competitive bidding would result in better pricing than through this cooperative contract. Mesa is eligible to utilize this contract as a U.S. Communities cooperative member.
