# IV. Discussion and Action Items

- A. Homeless Prevention Coalition Aaron Raine, Homeless Coordinator for the City, discussed the strategies being used and the priorities being addressed to help reduce homelessness in Mesa. Aaron discussed his role as Homeless Coordinator and discussed his efforts in working with downtown navigators, coordinating with various agencies and neighboring cities, and addressing other activities to get more help for the homeless.
- B. Review of FY 2018/2019 Application Evaluation Process Liz Morales presented an overview of the grants application funding recommendations which were presented to the Community & Cultural Development Committee (CCD) on March 1, 2018. Liz will be making a few revisions at the request of the CCD and will be presenting the revised recommendations to them again on Monday, March 5<sup>th</sup>. After the approval from the CCD, the recommendations will be presented to City Council. Liz thanked the Board members for their assistance in reviewing the applications. Discussion from the Board on the applications evaluation process included asking agencies to justify why they are asking for an increase, as well as asking what funding did the agencies receive last year and what did they accomplish with that funding. Further discussions/suggestions included reviewing the financials on a

red/green/yellow basis, as well as asking for just one proposal from each agency. The suggestion was made to visit these agencies each month as part of the Board meeting. Emily will check with Marc Center to see if they could be available for the Board's next meeting in April.

- C. Love Your Neighborhood Pilot Project Ray Thimesch presented an update on the project. The City has selected a contractor (Habitat for Humanity). Housing and Community Development is working with them right now and will continue working closely with them for the next several months to ensure they get off to a good start. Liz mentioned that the focus is primarily to address slum and blight (focusing on housing and curb appeal) and providing education, and working on long term sustainability in the neighborhood. The project area is from Extension to Robson, Broadway to 2nd Street. The City will also be using the City's volunteer program, as well as various City departments on this project, and may apply for additional funds for next year.
- D. City of Mesa Housing Authority Administrative Plan Liz Morales presented an overview of the Housing Authority 5-year Agency Plan and Administrative Plan. Every year Housing & Community Development gives HUD an update on the Housing Choice Voucher Program (operations/goals).
