Subject: Four-Year Term Contract for Payment Card Acceptance Security Services

Solution as requested by the Business Services and Information Technology

Departments (Citywide)

Recommendation

Council is requested to approve the award as recommended.

An evaluation committee representing the Business Services and Information Technology Departments, and Purchasing recommends awarding the contract to the highest-scored respondent, Hosted PCI at \$66,000.00 annually, based on estimated usage.

Background / Discussion

The City is looking for a hosted solution to accept card-not-present credit card transactions that is fully PCI compliant. The solution will provide the ability to take transactions through online, phone and IVR channels and allow for recurring payments. The solution will use a vault technology to tokenize credit cards for use in City hosted applications and provide an iFrame interface for accepting credit cards off-site that can be embedded into City hosted applications. The solution will integrate with the City's payment processor, Elavon. It is estimated that the transaction volume needed by the solution would approximate handle 900,000 transactions per year, with an estimated dollar value of \$140 million per year.

The City received five proposals of which all met the minimum requirements. The evaluation committee scored each response based on the evaluation criteria in the solicitation. The highest-scored respondent, HostedPCI, is being recommended for award. The evaluation committee unanimously agreed on the recommendation.
