Recommendation

Council is requested to approve the award as recommended.

The Information Technology Department, Human Resources Department, and Purchasing recommend authorizing the purchase using the State of Arizona cooperative contract with BPG Technologies, LLC for \$39,958.39 plus contingency at \$10,041.61, for the total amount of \$50,000.00, based on estimated requirements.

Background / Discussion

This purchase will provide fiber cable installation to connect the Mesa Employee Wellness Center to the City's high-speed data network. The Mesa Employee Wellness Center building, located at 1121 South Gilbert Road, currently receives network connectivity through a Digital Subscriber Loop (DSL) connection from a local telecommunications provider. Neither the DSL or previous cable connections can provide the speed or reliability required for the Wellness Center's daily operations.

Adding the Employee Wellness Center building to the City's fiber network will improve the reliability of the connection and speed, eliminate the existing monthly service cost for DSL, and reduce the need for additional network security hardware that is necessary for a Virtual Private Network (VPN) connection over cable or DSL. To minimize costs, the project will utilize existing City owned conduit and fiber.

BFG Technologies provided pricing based on State of Arizona contract pricing. The State cooperative contract was competitively bid, meets procurement requirements and prices are competitive due to volume contract pricing. It is unlikely that competitive bidding would result in better pricing than through this cooperative contract.
