AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MESA, ARIZONA ADOPTING TITLES AND SCHEDULES OF TERMS, RATES, FEES AND CHARGES FOR CITY-OWNED WATER UTILITIES

WHEREAS, the City Council of the City of Mesa has had multiple staff presentations, received public comments, conducted public hearings, and received various documents and reports, including: the report and attachments with data supporting increased rates and rate components, fees and charges on file with the City Clerk in accordance with the Notice of Intention adopted March 19, 2018, which include cash flow projections indicating anticipated revenues from residential and nonresidential customers as well as the overall expenses for providing service; various reports and attachments provided at Council presentations; the City's Comprehensive Annual Financial Report for the fiscal year ended June 30, 2017 accepted by Resolution on January 22, 2018; the Resolution and accompanying documents authorizing the issuance and sale of utility systems revenue bonds adopted on April 16, 2018; the proposed Five-Year Capital Improvement Program for fiscal years ending 2019-2023; the proposed 2018/2019 budget; and the report and attachments accompanying this Ordinance; and,

WHEREAS, the City Council based on its review and consideration of the foregoing, finds and determines that the revised Titles and Schedules made a public record by Resolution adopted on May 10, 2018 reflect just and reasonable increases and adjustments in the rate components, fees and charges, and that the resulting rates, fees and charges in such Titles and Schedules are just and reasonable.

NOW THEREFORE, BE IT ORDAINED by the City Council of the City of Mesa, Maricopa County, State of Arizona, as follows:

<u>Section 1</u>: That the following Titles and Schedules of Terms, Rates, Fees and Charges for City-Owned Water Utilities, as made public record by Resolution adopted on May 10, 2018, three copies of which are on file and available for public use and inspection with the Office of the City Clerk, are hereby established or amended in their entirety, and adopted to be applicable for the utility billing cycles commencing on and after the effective date of this Ordinance:
