Subject: Proposed Changes to the Fee Schedule for the Police Department

Purpose and Recommendation

The purpose of this report is to recommend clarifications to the Police Department's fees and charges schedule to include the City Prosecutor's Office beginning in fiscal year 2018-2019.

Background & Discussion

Various fees are charged for services related to researching and providing records requests, materials requests, and other miscellaneous fees are charged by the Police Department. The City Prosecutor's Office receives similar records and materials requests. The proposed changes clarify that the existing Police Department fee schedule includes the City Prosecutor's Office.
