**Subject:** Purchase of Six Replacement Automated Side Loading Refuse Trucks for the

Environmental Management and Sustainability Department (Funded by the Utility Replacement Extension and Renewal Fund, Capital Enterprise

Fund, and the Solid Waste Development Fee) (Citywide)

### Recommendation

Council is requested to approve the award as recommended.

The Fleet Services, and Environmental Management and Sustainability Departments, and Purchasing recommend awarding the contract to the lowest, responsive and responsible bidder, Rush Truck Centers of Arizona dba Rush Truck Center Phoenix for \$2,278,924.62.

## **Background**

This purchase will provide six heavy-duty Automated Side Loading (ASL) refuse trucks specific for use in refuse collection/landfill application to support solid waste daily operations.

The six refuse trucks are being replaced as part of the ongoing City of Mesa vehicle replacement program managed by Fleet Services. These vehicles have met established criteria and will be either traded, auctioned, sold, or deployed to special uses.
