(SRPMIC), and \$27,253.96 by the Capital General Fund) (Citywide)

Recommendation

Council is requested to approve the award as recommended.

The Police Department and Purchasing recommend awarding the contract to the lowest, responsive and responsible bidder, PFVT Motors, LLC dba Peoria Ford for \$109,015.84.

Background

This purchase will provide a total of four Ford Taurus SEL sedans to support Police Operations.

One vehicle is an unscheduled replacement for a vehicle that was totaled in an accident and had to be replaced early funded by the Vehicle Replacement Fund. Two of the vehicle additions are for the Police Department's Field Intelligence Officer Program both granted funded by the SRPMIC. The third vehicle addition is for the new Assistant Police Chief funded by the Capital General Fund.
