A RESOLUTION OF THE COUNCIL OF THE CITY OF MESA, MARICOPA COUNTY, ARIZONA, AUTHORIZING THE CITY MANAGER OR HIS DESIGNATED REPRESENTATIVE, TO PREPARE, SIGN AND SUBMIT APPLICATIONS TO RECEIVE ENTITLEMENT FUNDS FOR FISCAL YEAR 2018/2019 UNDER THE HOUSING AND COMMUNITY DEVELOPMENT ACT OF 1974, AS AMENDED, TO FUND FOR-PROFIT ORGANIZATION ACTIVITIES, NON-PROFIT ORGANIZATION ACTIVITIES, AND CITY DEPARTMENT ACTIVITIES APPROVED BY THE CITY COUNCIL.

WHEREAS, the proposed activities to be undertaken were advertised and hearings held concerning the Community Development Block Grant ("CDBG"), in order to inform Mesa citizens and to receive comments regarding projects to be undertaken by the City in fiscal year 2018/2019 with the entitlement funds available for this program under the Housing and Community Development Act of 1974 ("Community Development Act"), as amended;

WHEREAS, the City Council was provided with recommendations of activities to be funded under the provisions of the Community Development Act, and has approved all activities and funding allocations;

WHEREAS, a proposed statement of the projected use of funds was completed in accordance with federal requirements and made available to the public; and

WHEREAS, the proposed activities to be undertaken by the for-profit organizations, non-profit organizations, and City departments meet the objectives and priorities as identified in the City's Five-Year Consolidated Plan.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MESA, MARICOPA COUNTY, ARIZONA, AS FOLLOWS:

Section 1: That the City Manager or his designated representative is hereby authorized to prepare, sign and submit applications, as well as any other necessary documents, to the U.S. Department of Housing and Urban Development for fiscal year 2018/2019 entitlement funds available to the City of Mesa under the Community Development Act for activities of for-profit organizations, non-profit organizations, and City departments as approved by the City Council.

<u>Section 2</u>: That the City Manager or his designee is authorized to sign and submit any amendments, modifications, or revisions to the documents authorized by this Resolution, without the further consent of the City Council, provided all said amendments, modifications, or revisions are in compliance with the funding recommendations of the City Council, the City's Five-Year Consolidated Plan, the CDBG program, and the Community Development Act.
