Subject: Three-Year Term Contract for a Fiber and Conduit Management System as

requested by the Information Technology Department, Engineering

Department, and Transportation Department (Citywide)

Recommendation

Council is requested to approve the award as recommended.

A committee representing the Information Technology, Engineering, and Transportation Departments, and Purchasing evaluated responses. The evaluation committee recommends awarding the contract to the highest scored proposal, 3-GIS LLC for \$224,930.00 plus contingency of \$23,198.60 and estimated sales tax of \$7,056.00, for the three-year project total of \$255,184.60.

Background

The City of Mesa currently maintains approximately 468 miles of fiber and conduit in 160 square miles of planning area. The data and information is currently managed through various processes and departments across the City but lacks a central uniform approach. There are multiple systems housing the information today with limited ability to share data for ease of access and effective decision-making.

This system will be instrumental in the development of a fiber and conduit management plan that would be used to guide the feasibility, planning, budgeting, and capacity of City resources. The plan will also be used to support decision making when the City receives requests for rental and in-kind development of fiber and conduit resources within its boundaries.

The City received three proposals which all met the minimum requirements. The evaluation committee scored each response based on the evaluation criteria in the solicitation. The highest-scored respondent, 3-GIS, is being recommended for award. The evaluation committee unanimously agreed on the recommendation.
