Subject: Purchase of Carbon Replacement for Aeration Basin Towers at the Greenfield and Northwest Wastewater Reclamation Plants as requested by the Water Resources Department **(Funded by Greenfield WRP Joint Venture Fund and Wastewater Operations and Maintenance) (Citywide)**

Recommendation

Council is requested to approve the award as recommended.

The Water Resources Department and Purchasing recommend awarding the contract to the lowest, responsive and responsible bidder, Carbon Activated Corp. at \$243,266.00.

Background / Discussion

This contract will provide a qualified contractor to replace carbon in the odor control tanks/towers at the Greenfield and Northwest Water Reclamation Plants. Services will include the removal and proper disposal of existing carbon and replacement with new carbon in each carbon tank/tower over a two-year period.

The Greenfield plant has three odor control tanks/towers and anticipates having the carbon replaced in two tanks/towers during the first year of the contract and the third tank/tower in the second year. The Northwest plant has three odor control tanks/towers and the department intends to have the carbon replaced in two tanks/towers and the carbon removed from the third tank/tower in the first year, so it can be decommissioned.
