Subject:	Purchase of Four Replacement CNG Powered Heavy-Duty Front-Loading Refuse Trucks for the Environmental Management and Sustainability Department (Funded by the Utility Replacement Extension & Renewal Fund and Capital Enterprise Fund) (Citywide)

Recommendation

Council is requested to approve the purchase as recommended.

The Fleet Services and Environmental Management and Sustainability Departments and Purchasing recommend authorizing the purchase from the existing contract with Rush Truck Centers of Arizona dba Rush Truck Center Phoenix for \$1,475,985.44.

Background / Discussion

This purchase will provide four CNG powered front-end loader refuse trucks for trash collection of the City of Mesa's commercial accounts. Solid Waste Management has been replacing diesel front-end loaders for trash collection of commercial accounts with CNG front-end trucks as part of the conversion of the fleet to CNG.

The four refuse trucks are being replaced as part of the ongoing City of Mesa vehicle replacement program managed by Fleet Services. These vehicles have met established criteria and will be either traded, auctioned, sold, or deployed to special uses.
