**Subject:** Three-Year Term Contract with Two Years Renewal Options for Fire

Protection Equipment Maintenance and Repair Services for the Parks,

Recreation and Community Facilities Department (Citywide)

#### Recommendation

Council is requested to approve the award as recommended.

A committee representing the Parks, Recreation and Community Facilities Department and Purchasing evaluated responses. The evaluation committee recommends awarding the contract to the highest scored proposal from Metro Fire Equipment, Inc., at \$251,700.00 annually with an annual increase allowance of up to 5% or the adjusted Consumer Price Index.

## **Background / Discussion**

This contract will provide fire protection, detection and suppression equipment maintenance and repair for 98 City facilities. A qualified contractor will maintain and repair the City's fire protection equipment to minimize potential safety risk to employees and citizens.

The City received seven proposals, of which, all vendors met the minimum qualifications. The evaluation team then evaluated and scored the responses based on the evaluation criteria in the solicitation. Award is recommended to the highest scored respondent, Metro Fire Equipment, Inc. The evaluation committee unanimously agreed on the recommendation.
