Subject: Purchase of 42 Replacement Scott Safety Powered Air Purifying Respirators

and 200 Scott Air Purifying Cartridges for the Fire & Medical Department (Funded by State Homeland Security Grant Program) (Citywide)

Recommendation

Council is requested to approve the award as recommended.

The Fire & Medical Department and Purchasing recommend awarding the contract to the single, responsive and responsible bidder, Municipal Emergency Services for \$51,653.41.

Background / Discussion

This purchase will provide 42 Scott Safety Powered Air Purifying Respirators (PAPR) model C420 Plus and 200 Scott Air Purifying Cartridges. The new PAPRs will replace outdated PAPRs carried on Fire & Medical's heavy rescue and mass decontamination units. PAPRs protect the first responder's respiratory system from harmful contaminants and allow for longer work cycles with full face mask backpressure protection.

Fire & Medical utilizes approximately 300 Scott self-contained breathing apparatus (SCBA) on its heavy rescues and mass decontamination responding units. Over 400 first responders have already been issued a Scott face mask to be used with the current SCBA's. These new PAPRs will be utilizing the first responder's current mask when wearing these PAPRS which will reduce the need for additional equipment, mask testing, and care/maintenance.

Purchasing released a solicitation for Scott Safety Powered Air Purifying Respirators and Cartridges on 7/18/2018. The bid closed 15 days later. One vendor, Municipal Emergency Services (MES), responded. There are other distributors for these products, but typically MES is the only vendor who responds since they are the largest supplier of Scott Safety Air products. They also have a local office in Tempe.
