Proposed Banner Health / Select Medical Rehabilitation Hospital Project

Banner and Select Medical History

The proposed Banner Rehabilitation Hospital, a joint venture between Banner Health and Select Medical, will provide physical rehabilitation in the Phoenix Metro area. Banner Health was formed in 1999 as a non-profit health care system and currently operates in 7 states. Their system consists of 28 acute care hospitals, 2 academic teaching hospitals, out-patient clinics, over 2,000 doctors, and out-patient cancer centers with MD Anderson. Select Medical was founded in 1996 and currently operates more than 100 long-term acute care hospitals, 19 inpatient rehabilitation hospitals, and nearly 1,500 outpatient service centers. Together these two innovative organizations have teamed to develop a for-profit, inpatient rehabilitation facility to deliver state-of-the-art patient physical rehabilitation therapies and services.

Project Overview

The proposed Banner-Select Rehabilitation Hospital, located at the southwest corner of Highway US 60 and 48th Street/Pierpont Drive, will be a 1-story 61,115 square foot building with 56 private room inpatient beds. The strategic location for this site is within the service areas of Banner Gateway Medical Center as well as within a demographic area needing multiple levels of physical rehabilitation care. The proposed project is an inpatient facility where patients receive medical care for physical rehabilitation. On average patients will receive rehabilitation at the facility for 14 consecutive days.

The site is currently vacant agricultural land owned by Banner Health. The site is bordered by US 60 to the north, Banner Gateway Medical Center to the east and undeveloped land to the south and west. The location is an area designated for Light Industrial Planned Area Development (Zone LI PAD) with Hospital as a permitted use with the existing zoning, but will be rezoned to remove the PAD component to be only Light Industrial, LI. The overall site (APN 140-68-005F) consists of 22.213 acres. This project proposes to develop 5.33 acres for the Banner Rehabilitation Hospital phase and the remainder 16.883 acres to be developed as a future phase of the Banner Gateway Medical Center. A concept of the layout has been provided for context.

The Banner Rehabilitation Hospital is designed to showcase an architectural design that complements the surrounding developments. The site provides enhanced landscape areas around the building base and proposes the loading zone on the east of the site, with access from Pierpont Drive.

Special Use Permit request

Due to the proposed rehabilitation Hospital's unique qualities of long term stay and Select Medical's experience as operators of similar facilities locally and nationally, this project requests to reduce the required code parking spaces to 2 spaces per patient bed, which exceeds the Nationally recognized 2014 Facility Guidelines Institute's Guidelines for Design and Construction of Hospitals and Outpatient Facilities of 1 space per 4 patient beds and 1 per employee, versus the City of Mesa parking requirements based on 1 space per 400 sf of building. The 2 spaces per patient bed is based upon the following parking patterns for the hospital;

The Rehabilitation Hospital staffing will consist of 150 full-time equivalent employees that arrive and leave at various times during its 24-hour operation (weekend and weekday shifts vary). The peak parking demand based upon a conservative measure of one (1) employee per car occurs on weekday mornings when the day shift staff of eighty-three (83) have arrived, the twenty-seven (27) night staff leave with the twenty-five (25) administrative employees arriving after the night shift change, and the average five (5) visitors per hour per day arrive for a total of 113 spaces. Based on the parking operations at this and other facilities the on-site operational parking

requirements for the Select Medical physical rehabilitation facilities is two (2) spaces for every bed based on the actual Select Medical facilities operations.

A table comparing the City of Mesa Zoning Ordinance required parking and the proposed parking is provided below:

The proposed rehabilitation hospital proposes 123 spaces for the development.

Banner Health and Select Medical look forward to working with the City of Mesa on this \$23.7M investment to their community. In an effort to obtain Certificate of Occupancy by late end of 2019, our team will seek expedited reviews and at-risk submittals where available.


SWC US-60 & 48TH STREET/PIERPONT DRIVE PRELIMINARY GRADING AND DRAINAGE PLAN

1.0 INTRODUCTION

1.1 PROJECT DESCRIPTION

Select Medical Corp in partnership with Banner Health is proposing to build a 61,115 square foot physical Rehabilitation Hospital at the southwest corner of Highway US 60 and Pierpont Drive. The site is currently zoned Light Industrial Planned Area Development, LI PAD, per the City of Mesa zoning map. The physical Rehabilitation Hospital development will rezone the entire 22.21± acres to standard Light Industrial, LI. The proposed rezoning and site plan review process through the City of Mesa requires a Citizen Participation Plan.

1.2 LOCATION

The proposed physical Rehabilitation Hospital development encompasses approximately 5.33± acres of the overall 22.21± acre parcel in a portion of the Southwest Quarter of Section 34, Township 1 North, Range 6 East of the Gila and Salt River Base and Meridian in Maricopa County, Arizona. The site at the southwest corner of Highway US 60 and 48th Street/Pierpont Drive, and is APN 140-68-005F. More specifically, the development is bounded by Highway US 60 to the north, Pierpont Drive to the east, Vacant land zoned Limited Industrial to the south, and multifamily PAD to the west (See Appendix A for Site Location Map and Legal Descriptions).

1.3 PURPOSE

This Citizen Participation Plan outlines the notification efforts and input received from the surrounding community regarding the proposed Banner Rehabilitation Hospital at the SWC of Highway US 60 and 48th Street/Pierpont Drive.

2.0 PROJECT NOTIFICATION

2.1 NOTIFICATION AREA

In accordance with the City of Mesa Citizen Participation Plan requirements provided at the pre-application meeting an area of 1000' surrounding the subject project was selected as the required notification area. See Appendix B for Neighborhood Notification map.





1.1 PROJECT DESCRIPTION

Select Medical Corp in partnership with Banner Health is proposing to build a 61,115 square foot physical Rehabilitation Hospital at the southwest corner of Highway US 60 and Pierpont Drive. The site is currently zoned Light Industrial Planned Area Development, LI PAD, per the City of Mesa zoning map. The physical Rehabilitation Hospital development will rezone the entire 22.21± acres to standard Light Industrial, LI. The proposed rezoning and site plan review process through the City of Mesa requires a Citizen Participation Plan.

1.2 LOCATION

This Citizen Participation Plan outlines the notification efforts and input received from the surrounding community regarding the proposed Banner Rehabilitation Hospital at the SWC of Highway US 60 and 48th Street/Pierpont Drive.

2.0 PROJECT NOTIFICATION

2.1 NOTIFICATION AREA

In accordance with the City of Mesa Citizen Participation Plan requirements provided at the pre-application meeting an area of 1000' surrounding the subject project was selected as the required notification area. See Appendix B for Neighborhood Notification map.

2.2 MAILING LIST

From the City of Mesa and Maricopa County records a list of City-wide list of interested parties, property owners within the 1000' notification area, registered neighborhoods within 1 mile, and Home Owner Associations (HOA) located within $\frac{1}{2}$ mile were obtained. See Appendix B for the mailing list of City-wide interested parties, property owners, registered neighborhoods, and HOA's.

2.3 CONTACT DATES

The City-wide interested parties, property owners, registered neighborhoods, and HOA's in the mailing will be contacted through first class mail to notify them of the proposed project. The community was notified on the following dates regarding the proposed Banner Rehabilitation Hospital.

May 29, 2018

The letters and attachments that were included in the mailing notifications are included in Appendix D. A neighborhood meeting was conducted on June 12, 2018 at the adjacent Banner Hospital to solicit neighborhood input.

2.4 CORRESPONDENCE RECEIVED

One adjacent property owner, Josh Brimhall, attended the neighborhood meeting. Josh as interested to see what the development consisted of and what portion of the vacant area was being developed. Josh did not have any comments regarding the development. All other individuals listed on the sign-in sheet are associated with the design and construction of the proposed facility.






