Subject: Purchase of Four Sport Utility Vehicles (Two Replacements and Two

Additions) for the Police Department (Funded by the Vehicle Replacement

and Capital General Funds) (Citywide)

Recommendation

Council is requested to approve the purchase as recommended.

The Fleet Services and Police Departments and Purchasing recommend authorizing the purchase from the existing contract with Midway Chevrolet at \$164,528.56.

Background

This purchase will provide four Police Patrol SUVs to support Police Operations. The two vehicles that are being replaced have met established criteria and will be either traded, auctioned, sold, or deployed to special uses as part of the ongoing City of Mesa vehicle replacement program. The Police Department received approval for two Police Service Officer positions and the associated vehicles for FY 2018/19. These vehicle additions are funded by the Capital General Fund.

The vehicles are additional purchases from a contract Council awarded on February 6, 2017 that allows for additional purchases.
