

- Secondhand Dealers
 - Automated Kiosks

City Code Updates

ECO ATM

- Ordinance applies to all second hand kiosk operators, not just ECOATM
- Requires a one-time company application (Proposed \$500)
- Requires a license issuance fee for each kiosk (\$500) and a yearly renewal fee for each license (\$500)
- Each location goes through an approval process

ECO ATM

- Live Rep required (Video)
- ID Required from the seller
- Access to goods by PD upon request and hold periods on goods acceptable by PD
- Suspension and revocation process/hearing process/appeal process
- Convictions are a class one misdemeanor if convicted

Second Hand Modifications

- Updates definitions to be in line with state regulations
- Updates sections to be more consistent with other City codes
- Updates fingerprint requirements to be in compliance for DPS
- Updates verbiage to reflect new online tickets/forms

Second Hand Modifications

- Updates Police hold requirement-propose 20 day hold
- Modified our verbiage to allow for all peace officers to access kiosks, not just Mesa PD
- Appeal process updated to be consistent with other City codes
- Exempts license requirements for automated 2nd hand kiosk operators

SUBJECT: Appointments to Boards and Committees.

The following are my recommendations for appointments to City of Mesa Advisory Boards and Committees.

Housing and Community Development Advisory Board – Eleven-member board with two reappointments.

Susan Brenton, District 4. Ms. Brenton is the president and owner of Association Management Company and executive director of Manufactured Housing Communities of Arizona. She holds a Bachelor's Degree in Accounting from Arizona State University. She will serve as the Board's manufactured housing representative. Ms. Brenton's term will expire June 30, 2021.

<u>Tom Stapley</u>, District 1. Mr. Stapley is the founding partner and managing director of Treehouse Group Companies, an entrepreneurial real estate company with a cash flow real estate focus. In addition, he has over a decade of experience acquiring, managing, and selling student housing and single family homes. Mr. Stapley volunteers his time with the Boy Scouts of America Venture Scouting Program. His term will expire June 30, 2021.

Mesa Housing Services Governing Board – Eight-member board with one new appointment

<u>Gary Nelson</u>, District 4. Mr. Nelson is a veteran who is currently employeed as a Pharmacy Tech Trainee with Alliance RX Walgreens Prime home delivery. He has been involved with the HUD-VASH program for three years and was accepted as a member of the Mesa Housing Resident Advisory Board last year. Mr. Nelson's appointment will be filling a vacancy created by the resignation of Kenneth Dennis. His partial term will expire Decemeber 31, 2018.



Human Relations Advisory Board – Eleven-member board with one new appointment.

<u>Ron Williams</u>, District 1. Mr. Williams is the owner of Contacts to Contracts, LLC. Prior to the establishment of his own business, Mr. Williams was the President/CEO of the Grand Canyon Minority Supplier Development Council. Mr. Williams has earned many awards and recognitions for his work to foster diversity and inclusion across Arizona. Mr. Williams will be filling a current vacancy on the Board. His partial term will expire June 30, 2020.

Judicial Advisory Board - Seven-member board with one new appointment.

<u>Kevin Humphrey</u>, District 5. Mr. Humphrey is the Vice President and Executive Director of Sunshine Acres Children's Home. He is also the owner of a small business technology startup and laundromat. Mr. Humphrey holds a Bachelor's Degree in Information Technology from the University of Phoenix. His term will expire June 30, 2021.

Museum & Cultural Advisory Board – Eleven-member board with one new appointment.

<u>Ivan Martinez</u>, District 4. Mr. Martinez is the owner of Ivan Martinez Photography as well as an Adjunct Photography Professor at Grand Canyon University. Previous roles include Operation Manager with azcentral.com and Sales Manager for the Seattle Times Digital Media. Mr. Martinez holds a Bachelor's Degree in Marketing and Advertising and a MBA from the University of Northern Iowa. Mr. Martinez is a current Board Member of both the Arizona Highways Photo Escapes and Downtown Merchants Association. He is a past Board Member of the IDEA Museum and Arizona Professional Photographer Association. Mr. Martinez's appointment will be filling a vacancy created by the resignation of Michael Darr. His partial term will expire June 30, 2020.

Transportation Advisory Board – Eleven-member board with one new appointment.

<u>Amanda Abou-Eid</u>, District 1. Ms. Abou-Eid is an owner and baker at Proof Bread. She previously held business and financial services roles with American Airlines and Bank of America. She holds a Bachelor of Science in Finance from Arizona State University. Through her work as a community baker, and in other roles, Amanda hopes to create a greater sense of community in her neighborhood. Ms. Abou-Eid's appointment will be





filling a vacancy created by the resignation of Michael Book. Her partial term will expire June 30, 2019.
