A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESA, MARICOPA COUNTY, ARIZONA APPROVING AND AUTHORIZING THE CITY MANAGER TO ENTER IN TO AN INTERGOVERNMENTAL AGREEMENT WITH THE SALT RIVER PIMA-MARICOPA INDIAN COMMUNITY, AND ANY SUBSEQUENT AMENDMENTS THERETO, FOR THE RECEIPT AND DISTRIBUTION OF \$955,000 IN PROPOSITION 202 FUNDS AND ADMINISTER AWARDED FUNDS AS PASS-THROUGH GRANTS TO DESIGNATED AWARDEES.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESA, MARICOPA COUNTY, ARIZONA AS FOLLOWS:

Section 1: Arizona's Indian Gaming Compact provides that an Indian Tribe make twelve percent (12%) of its net annual State contribution to cities, towns or counties for government services that benefit the general public.

Section 2: The Salt River Pima-Maricopa Indian Community wishes to enter into an Intergovernmental Agreement with the City of Mesa to receive and distribute \$955,000.00 from its 2017 12% revenues for grants as follows:

\$ 700,000.00 to the **City of Mesa** for the **Mesa Fire and Medical Department** Immunization Program, (\$85,000); **Housing Authority**, Affordable Housing Landlord Recruitment and Retention (\$51,000); **Parks, Recreation and Community Facilities**, Positive Play Project (\$50,000); **Library**, Red Mountain Monarch Haven and Reading Sanctuary (\$81,500); **Police Department**, Field Traffic Lidars Equipment Upgrade (\$60,720), Sex Offender Notification Enforcement (\$46,920), Crisis Response Team Training (\$22,300), Bomb Disposal Unity Safety (\$14,820), Explorer Program Activities (\$18,953); **Water Resources**, Know your H2O Community Education (\$44,200); **Planning Department**, Historic Neighborhood Calming (\$3,000); **City Manager's Office**, Downtown Façade Improvements (\$100,000), and Mesa K-Ready, Kindergarten Readiness Program (\$121,587).

\$ 75,000.00 to **A New Leaf, Inc.**

\$ 75,000.00 to the **Child Crisis Center**.

\$ 35,000.00 to **Gene Lewis Boxing Club**.

\$ 20,000.00 to **Visit Mesa**.

\$ 50,000.00 to **United Food Bank**.

Section 3: The City Council supports these grants and authorizes the City Manager, or his designee, to enter into the proposed Intergovernmental Agreement with the Salt River Pima-Maricopa Indian Community, and any subsequent amendments thereto, to

accept and administer the 2018 awarded Salt River Pima Maricopa Indian Community Proposition 202 funding.
