Subject:	Consider Forming the 2020 Census Taskforce <b>Citywide</b>

#### **Purpose and Recommendation**

The purpose is the appointment of the 2020 Census Taskforce. This taskforce will be responsible for developing the strategic outreach and engagement plan for city residents. This outreach is essential to ensuring an accurate count by the U.S. Census Bureau. The taskforce relies on community influencers to create localized messaging that educates and motivates people to respond to the 2020 U.S. Census.

#### Background

Article 1 of the United States Constitution requires all individuals to participate in a decennial census to count persons for purposes of representative apportionment. In 2015, Arizona received \$1,979 in federal assistance per capita to fund vital community programs such as Medicaid and Medicare Part B, SNAP (food stamps), highway planning and construction, title I grants to local education agencies and The State Children's Health Insurance Program. The City of Mesa receives an estimated \$330 a year in state shared revenue per capita to fund critical community services.

Beginning with the 1990 census, the U.S. Census Bureau introduced Complete Count Committees (CCCs) as a way to leverage local knowledge to ensure a more accurate count of the population. Today, most states and hundreds of cities, counties and tribes in Arizona and across the nation utilize CCCs to maximize voluntary response rates to the Census. The 2020 Census Taskforce is Mesa's CCC. The Taskforce's role is to develop the overall outreach and messaging strategy and coordinate implementation.

City staff presented at the March 29<sup>th</sup>, 2018 study session and were instructed by the Mesa City Council to seek volunteers from key community organizations and to return to Council at a future date to officially form the taskforce.

The taskforce will disband in the summer of 2020 after most of the nonresponse followup has concluded.

### **Fiscal Impact**

Marketing and outreach activities related to the 2020 Census will have a fiscal impact. The Taskforce will develop a strategic plan for census related outreach and messaging and return to Council in early 2019 with a funding request to support the recommended activities. The Taskforce may also attempt to seek donations and leverage in-kind resources from the community for the development and implementation of activities outlined within the strategic plan.

The Taskforce will attempt to increase response rates from individuals that would otherwise not be counted, thereby increasing population driven revenues to the City over the next decade.
