



BENCHMARK

THE BENCHMARK USED FOR THIS PLAN IS THE CITY OF MESA BENCHMARK BEING A BRASS TAG IN TOP OF CURB ON THE SOUTHEAST CORNER OF THE INTERSECTION OF SOUTHERN AVENUE AND ELLSWORTH ROAD HAVING AN ELEVATION OF 1481.20 FEET (NAVD88), CITY OF MESA DATUM.
