EXCEPT the West 40 feet thereof.

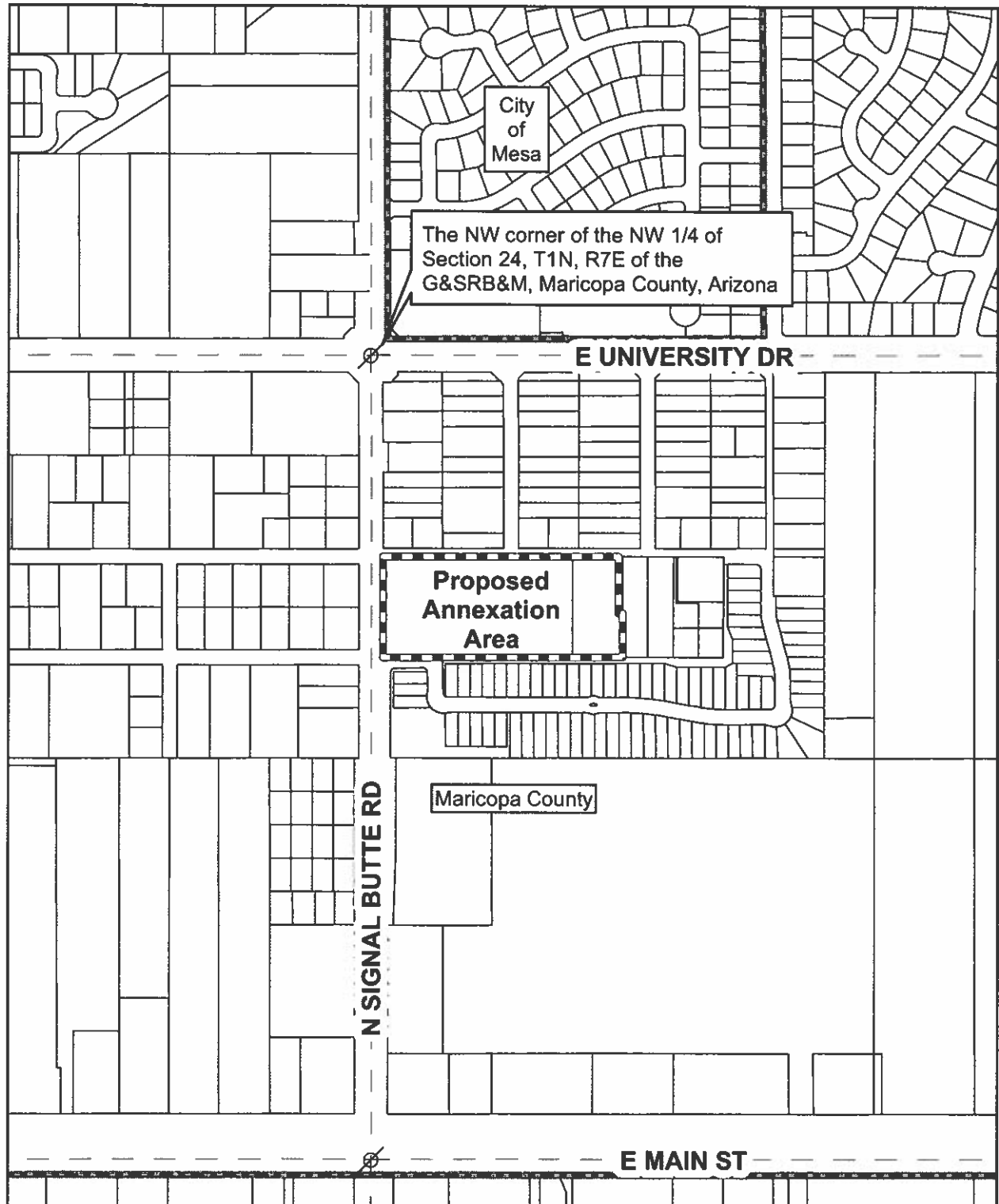
