**Subject:** Three-Year Term Contract with Two Years of Renewal Options for CCure Security and Closed-Circuit Television (CCTV) Parts, Service and Licensing for Various City Departments as requested by the Police Department  
(Citywide)

## Recommendation

Council is requested to approve the award as recommended.

A committee representing the Parks, Recreation and Community Facilities, Financial Services, and Police Departments and Purchasing evaluated responses. The evaluation committee recommends awarding the contract to the highest scored proposals from ADT Inc. dba MSE Corporate Security (Primary); and APL Access & Security, Inc. (Secondary); at \$500,000 annually with an annual increase allowance of up to 5% or the adjusted Consumer Price Index.

## Background / Discussion

This contract will be used by Police Department – Information Technology (PDIT) for upcoming CCure and CCTV projects. This contract will also be available to other City Departments for projects identified at their facilities.

The City received four proposals of which all met the minimum qualifications. The evaluation committee then evaluated the responses based on the evaluation criteria in the solicitation. Award is being recommended to the two, highest scored proposals: ADT Inc. dba MSE Corporate Security as the Primary Award; and APL Access & Security, Inc. as the Secondary Award; these proposals best meet the City's requirements. The evaluation committee unanimously agreed on the recommendation.
