Subject:	Purchase of Three Sport Utility Vehicles (One Replacement and Two Additions) and One Minivan (Replacement) for the Police Department (Funded by the Capital General Fund and Vehicle Replacement Fund) (Citywide)

Recommendation

Council is requested to approve the purchase as recommended.

The Fleet Services and Police Departments, and Purchasing recommend authorizing the purchase from the existing contracts with Midway Chevrolet at \$123,430.53 and Larry H. Miller Toyota at \$36,802.99, for the combined total of \$160,233.52.

Background / Discussion

The two vehicles that are being replaced have met established criteria and will be either traded, auctioned, sold, or deployed to special uses as part of the ongoing vehicle replacement program.

The Police Department received approval for four Police Officer positions and two vehicle additions for FY 2019. The two additions are funded by the Capital General Fund.

All four vehicles will be used to support daily Police Operations.

The vehicles are additional purchases from contracts Council awarded on February 6, 2017, and June 27, 2017, that allow for additional purchases.
