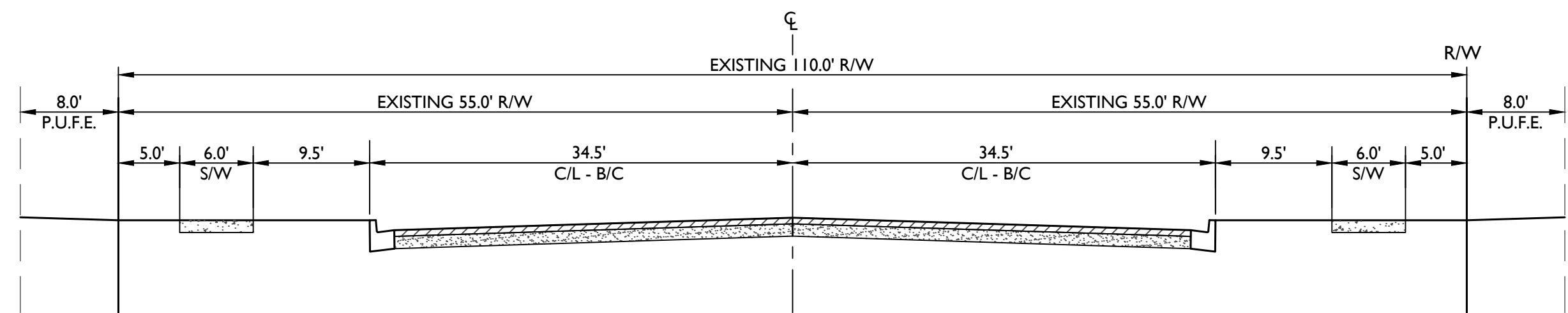


PARCEL 3 OPTION WITH SCHOOL PARCEL



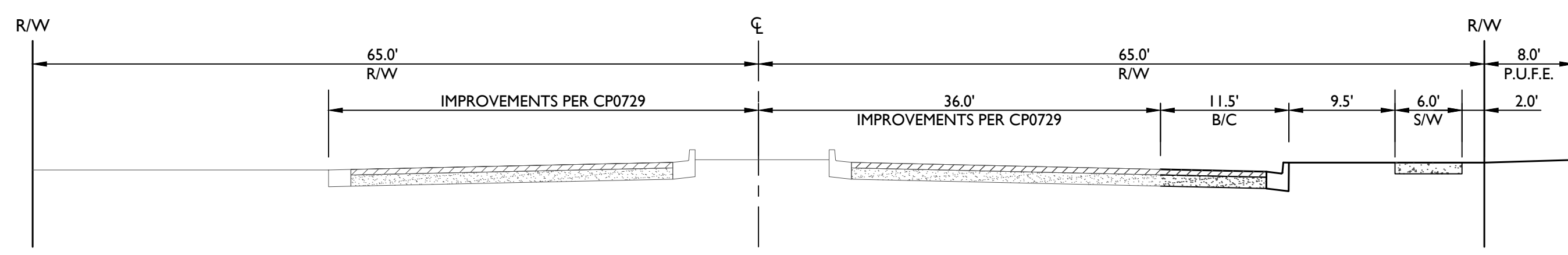
MODIFIED INTERNAL COLLECTOR

MOUNTAIN ROAD (4-LANE MAJOR COLLECTOR)

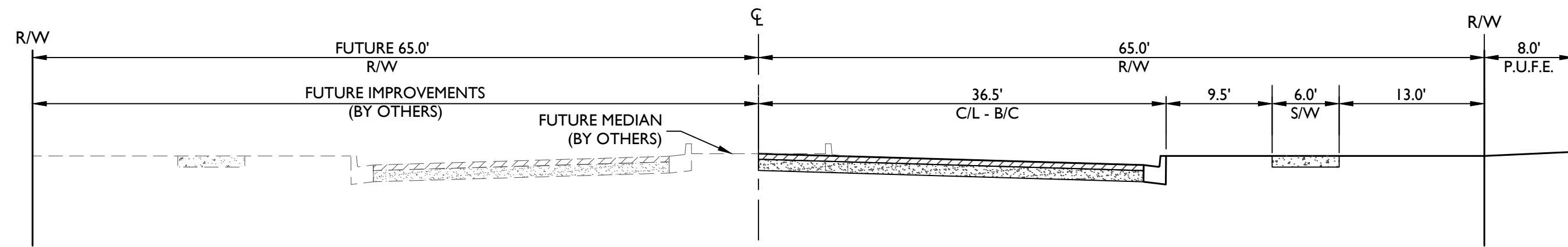

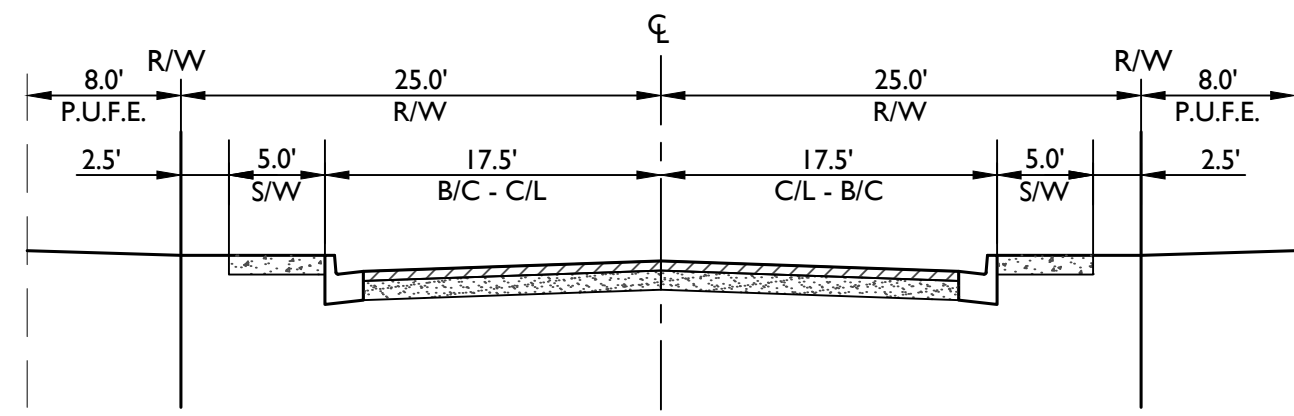

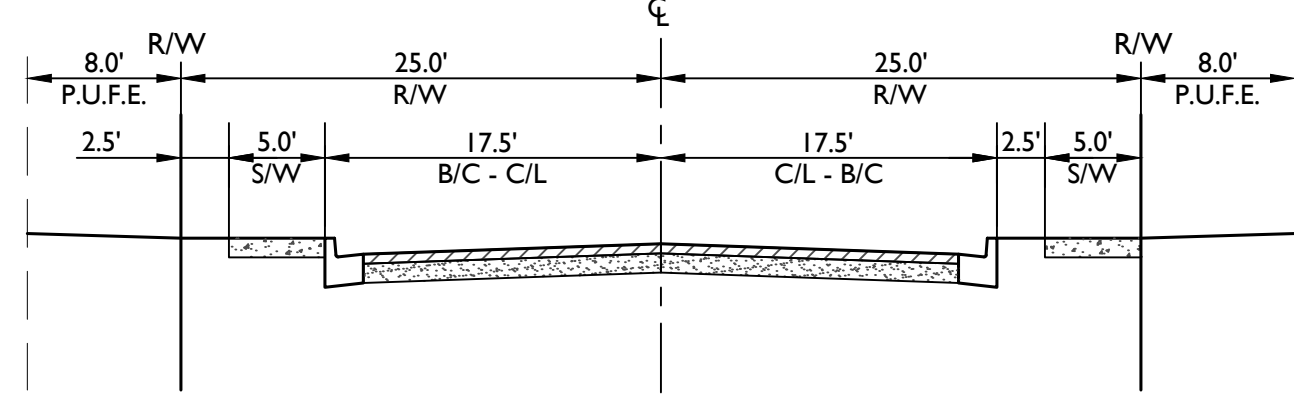
