| Subject: | Three-Year Term Contract with Two Years of Renewal Options for SCADA Rugged Computers and Support Services for the Water Resources Department (Funded by Information Technology Lifecycle Replacement Funds, and Water and Wastewater Operations and Maintenance budget) (Single Response) (Citywide) |

Recommendation

Council is requested to approve the award as recommended.

A committee representing the Water Resources Department and Purchasing evaluated the proposal response. The evaluation committee recommends awarding the contract to the single, responsive and responsible proposal from Hypertec USA Inc., dba Hypertec Direct, Year 1, at \$211,600; and Years 2 and 3 at \$150,000 annually, with an annual increase allowance of up to 5%, or the adjusted Consumer Price Index; based on estimated requirements.

Background / Discussion

This contract will provide Schweitzer Engineering Laboratories, Inc. (SEL) sealed SCADA rugged mini-computers and support services for the Water Resources and Energy Departments. The City anticipates purchasing approximately 14 to 16 rugged computers during the first year and additional purchases will be made as needed during the term contract.

Because this is a limited source area for sealed SCADA rugged mini-computers with long term warranties, the City issued a Request for Proposal (RFP) to establish a contract with favorable terms and conditions, and pricing, for the City. A single response was received and therefore, the City was not able to perform a comparative analysis. The proposal was evaluated in accordance with the City's established policies and procedures.

The evaluation committee deemed Hypertec Direct's proposal as responsive to the RFP specifications and requirements. Water Resources confirmed the proposal pricing was fair and reasonable. Purchasing confirmed the proposal pricing is accurate and the vendor will be able to acquire the SEL mini-computers.
