1. Chair Dahlke declared a quorum present and the meeting was called to order at 7:32 a.m.
2. Review items on the agenda for the February 20, 2019 regular Planning and Zoning Board Hearing.

There was no discussion or updates on the items on the agenda.

3. Receive a presentation and discuss the update to the City's Quality Design Guidelines.

Staffmember Veronica Gonzalez presented an update to the City's current review of Quality Design Guidelines along with the hired consultant, Matt Klyszeiko with Michael Baker Int'l.

4. Planning Director's Updates.

Nana Appiah, Planning Director, discussed several process improvement changes being implemented. He explained beginning February 25, staff will accept two submittal deadlines each month instead of the current process of accepting submittals once a month. Mr. Appiah stated staff presented this to the development community and it has been well received. He explained the revised submission and review process will also provide an opportunity for applicant to sit down with staff and resolve concerns associated with an application. The goal is to eliminate last minute negotiations and changes due to unresolved review comments.

Mr. Appiah stated another improvement is to implement an additional Planning and Zoning Board hearing per month and eliminate the Tuesday morning study sessions. He explained staff is anticipating starting the twice a month P&Z meeting in May.

Boardmember Allen inquired if staff would have the appropriate time to respond to questions from Board members if the study session on Tuesday is eliminated. Mr. Appiah responded the goal is to have a study session prior to regular hearing on Wednesday and staff has a goal to ensure the staff reports address majority of likely questions from the Board. He also explained staff is working on measure to eliminate last minutes changes and the rush to complete reports when there are still outstanding issues.

Planning Director Nana Appiah reminded the Board of the upcoming retreat with EDAB. Chair Dahlke stated the retreat is in conjunction with the Economic Development Advisory Board.

5. Adjournment.

Boardmember Villanueva-Saucedo motioned to adjourn the meeting at 8:30 am. The motion was seconded by Boardmember Allen.
