Purpose

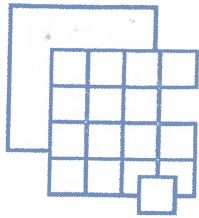

Dear Neighbor:

Together with our client, we are pleased to invite you to a third neighborhood meeting to receive your comments on our applications to the City of Mesa for DESTINATION at Gateway, a 198-acre development located at the southeast corner of Signal Butte and Williams Field Road. In June of 2018, the Mesa City Council approved the General Plan amendment and rezoning of the property to allow a residential master planned community and a commercial development at the NEC of Hwy 24 and Signal Butte Roads. The property owner is now working with the City to create a subdivision plat to carry forward to vision of the original plan. In addition, we are requesting a rezoning PAD amendment to allow setbacks consistent with what has been previously approved in the area. The rezoning will NOT be changing any of the land uses.

The development requests to the City include the following:

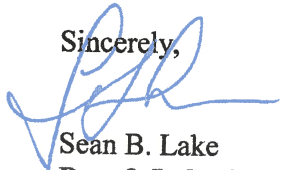
- 1) **An amendment to the Planned Area Development (PAD)** that was approved in June of this year. This amendment will establish the development standards (setbacks, lot sizes, lot coverages...) within the previously approved zoning districts. This amendment will implement the many community features that were discussed in prior neighborhood meetings. The previously approved *Community Vision Guidelines* are not affected by this request.
- 2) **Preliminary Plat approval.**

The neighborhood meeting has been scheduled to give property owners in the area an opportunity to meet with the applicant and property owner, and to learn more about the status of the project. At the meeting, we will have information available for your review and comment. The details of this meeting are as follows:

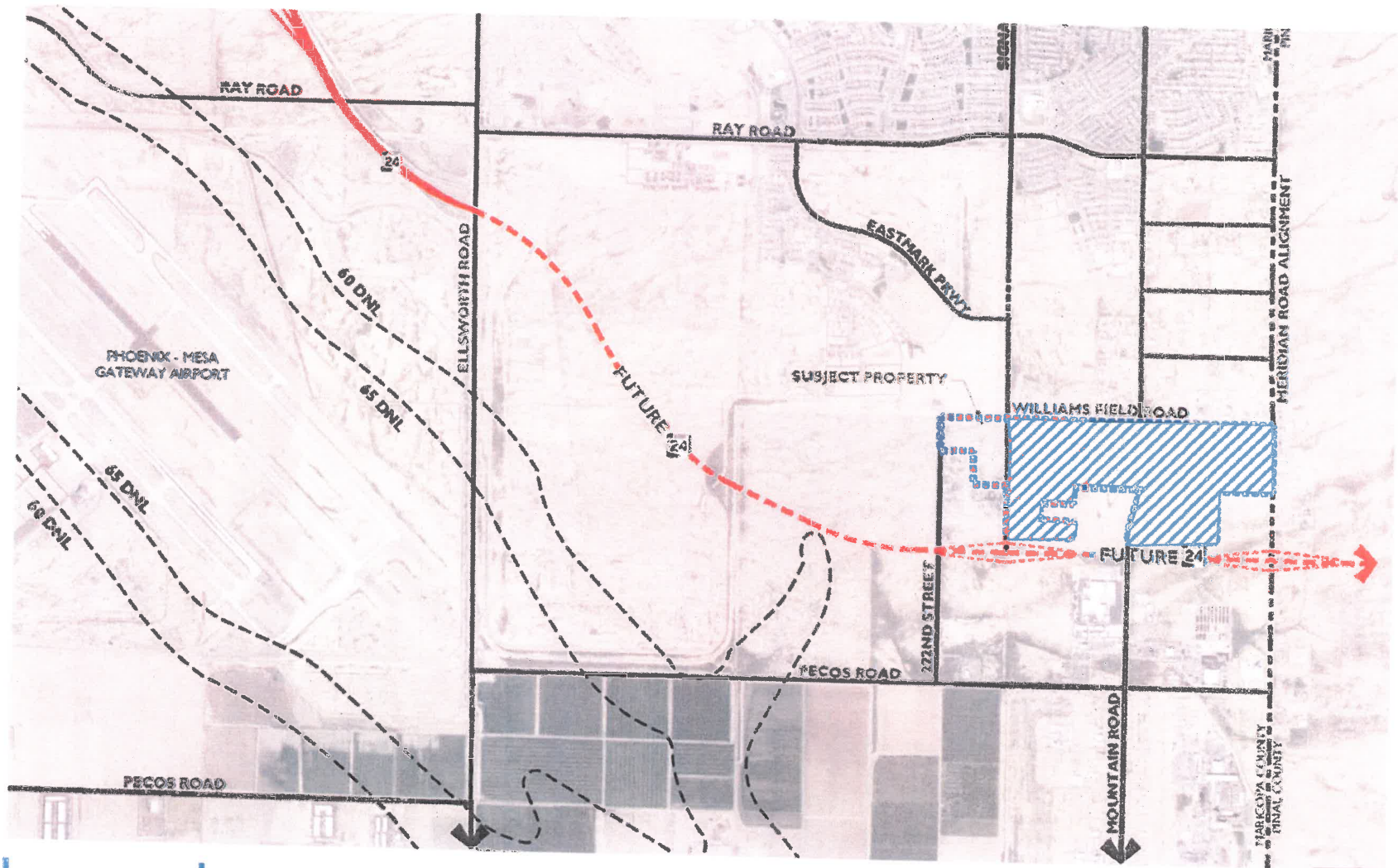

Neighborhood Meeting Summary

DESTINATION at Gateway

Mountain and Williams Field Roads

January 14, 2019

Meridien Elementary School, 3900 South Mountain Road

6:00 p.m.

The meeting was called to order by Sean Lake at 6:01 p.m. There were twenty (20) individuals in attendance. Sign-in sheets are attached to this summary. Mr. Lake introduced Mr. Brent Hickey and Gary Lane of Freedom Communities, who were also in attendance.

Mr. Lake discussed the actions that had been taken to provide notice for the neighborhood meeting and to indicate that we had already filed a formal application for a PAD Amendment and Preliminary Plat approval. Mr. Lake explained that this application was to implement and establish development standards for zoning districts that were established as part of the of the annexation, General Plan amendment and Rezoning of this property that was approved in June of 2018.

Mr. Lake indicated on the vicinity map the parcels that were part of the evening's discussion. He discussed the planned expansion of the 24 freeway and how it will create the perfect opportunity for a master planned development.

The proposed Preliminary Plat (attached) was on display at the meeting, as was a vicinity map. Mr. Lake walked through the proposed parcel configurations and the lot sizes that would be represented in each parcel. He indicated the areas on the site that would be open space and discussed the street configurations. He explained that the preliminary plat process is when subdivisions are designed, but that there was no housing product being considered at this time. Though there is a builder who has expressed an interest in developing the community, there were no elevations or floorplans that could be discussed. In general, the homes will be a mix of one-and two-story homes and they would all be single-family homes. They would be similar in style and variety to those homes found in Eastmark and Cadence.

He also explained that the next step in the development process would be to go through the subdivision technical review process. This process would provide further detail to the proposed community and establish water and sewer solutions.

Mr. Lake then opened the meeting up to questions and comments from the neighbors. The questions and responses **(in bold)** are shown below.

Question: What will happen to Williams Field Road? **Response: We will be responsible for improving the southern half of the road between Signal Butte and Meridien Roads. However, the City may reimburse us for improving the north side of the road where it is appropriate.**

Comment: We already have severe drainage problems along Williams Field Road. By building your development all of your water will drain on to our property. **Response: The City of Mesa will require us to retain all of the water that has historically flowed on and off of this property. We will be installing retention basins (above or underground) that will capture all of the water within this development. We are required to discharge this water where it has previously flowed from the site. With the engineering done with the design of this community, it will likely be an improvement to the drainage problems in this area. (As an aside, Mr. Lake asked for a show of hands for those residents who live in unincorporated Maricopa County. About half of the attendees indicated living in the County.)**

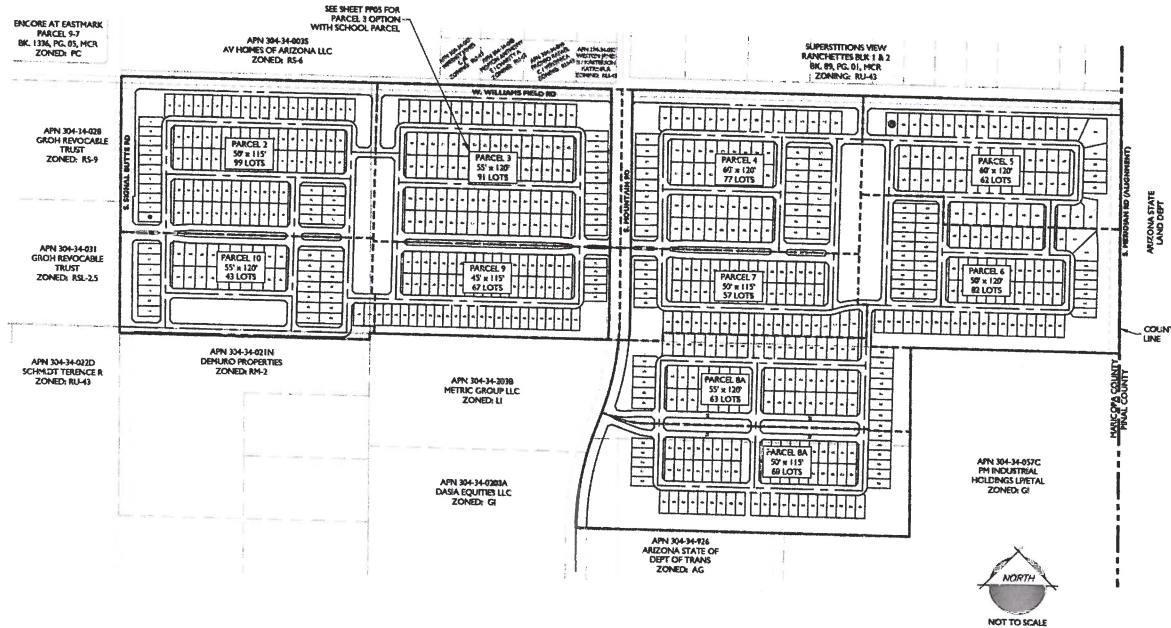
Question: Is there still a school planned for the community? **Response: Yes, we are just not sure of its exact location.**

Question: What is the timing for this project? **Response: Mr. Lake discussed the next steps in the entitlement process— that we have made a formal application for the preliminary plat and an amendment to the previously approved Planned Area Development. zoning case. These applications will be heard at the Planning & Zoning Board in February, and the Mesa City Council in March and April.**

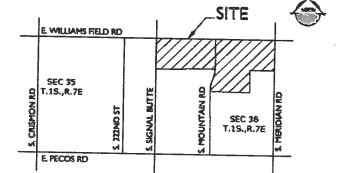
There being no further discussion, the meeting adjourned at 6:37 p.m.

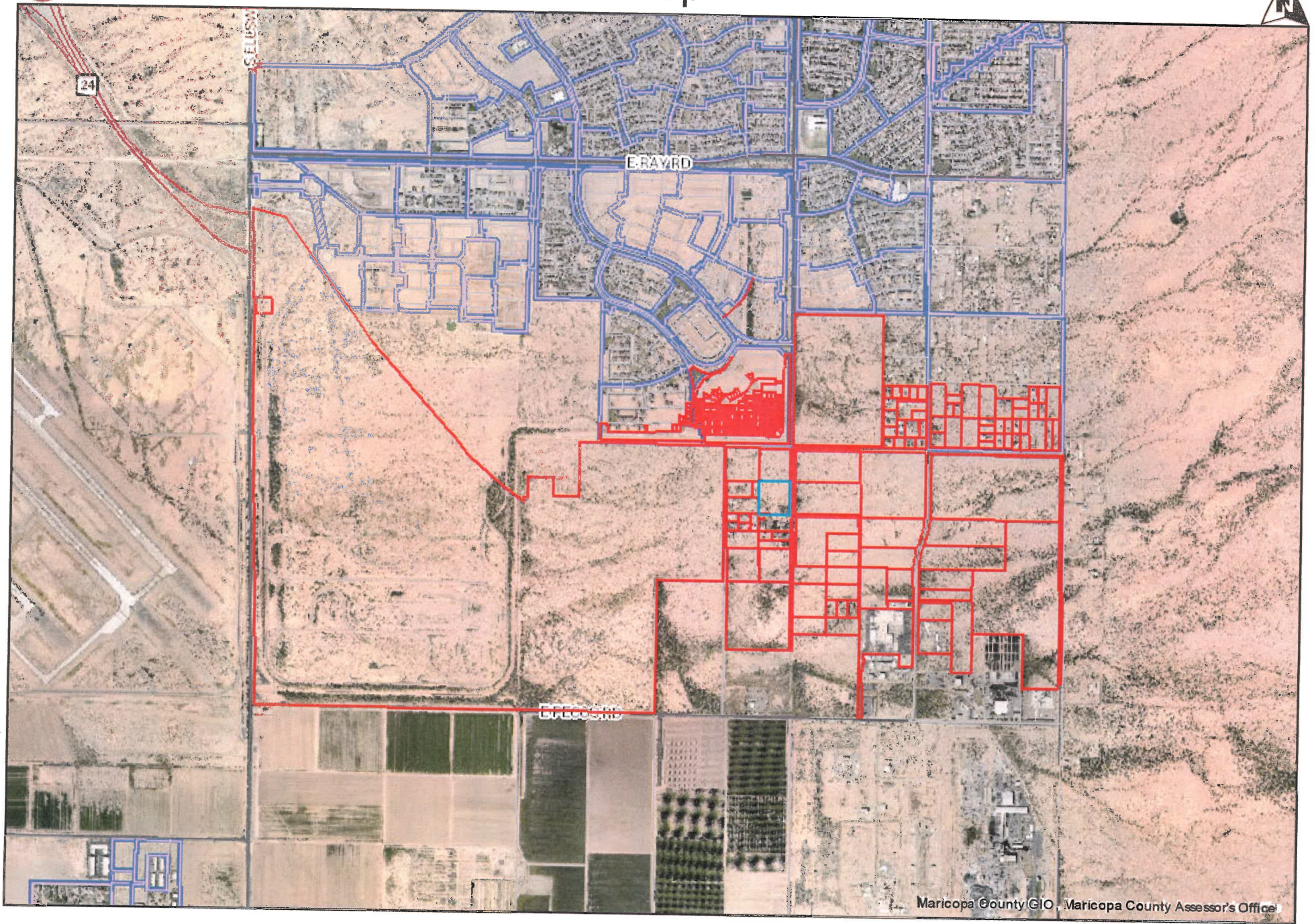
