

LEGAL DESCRIPTION - EASEMENT ABANDONMENT

A PORTION OF PARCEL B AND PARCEL C AS SHOWN IN A MINOR LAND DIVISION RECORDED IN BOOK 1170, PAGE 29 OF MARICOPA COUNTY RECORDS, LOCATED IN THE NORTHEAST QUARTER OF SECTION 18, TOWNSHIP 1 NORTH, RANGE 5 EAST OF THE GILA AND SALT RIVER BASE AND MERIDIAN, MARICOPA COUNTY, ARIZONA DESCRIBED AS FOLLOWS: COMMENCING AT THE EAST QUARTER CORNER OF SAID SECTION 18;

THENCE ALONG THE EAST-WEST MID SECTION LINE (BASIS OF BEARING) S89°27'10"W, A DISTANCE OF 1035.04 FEET; THENCE ALONG THE CENTERLINE OF NORTH RIVERVIEW NO0°16'58"E, A DISTANCE OF 554.01 FEET;

THENCE N89°43'02"W, A DISTANCE OF 62.00 FEET TO THE SOUTHEAST CORNER OF SAID PARCEL B;

THENCE ALONG THE SOUTH LINE OF SAID PARCEL B, S89'27'12"W, A DISTANCE OF 324.68 FEET TO THE SOUTHEAST CORNER OF SAID PARCEL C:

THENCE ALONG THE SOUTH BOUNDARY LINE OF SAID PARCEL C S89°27'12"W, A DISTANCE OF 220.55 FEET TO THE TRUE POINT OF BEGINNING (TPOB);

THENCE CONTINUING ALONG THE SOUTH BOUNDARY LINE OF SAID PARCEL C S89'27'12"W, A DISTANCE OF 20.00 FEET TO THE SOUTHWEST CORNER OF SAID PARCEL C;

THENCE ALONG THE WEST BOUNDARY LINE OF SAID PARCEL C NO0°32'48"W, A DISTANCE OF 99.38 FEET TO THE NORTHWEST CORNER OF SAID PARCEL C:

THENCE DEPARTING SAID PARCEL C AND CONTINUING NO0'32'48"W, A DISTANCE OF 61.83 FEET;

THENCE S89'43'02"E, A DISTANCE OF 20.00 FEET:

THENCE S00'32'48"E, A DISTANCE OF 61.54 FEET TO A POINT ON THE NORTH LINE OF SAID PARCEL C;

THENCE CONTINUING S00°32'48"E, A DISTANCE OF 99.38 FEET TO THE TPOB.
